SUBJECT: *Activity Report – June 2020*

1. *Crime and Patrol Summary*

See attachments. The department responded to 1,220 requests for service during the month of June. Community Service responded to 123 requests for service.

This month, officers were involved in a couple of incidents that netted a substantial amount of drugs from individuals in our community.

The first incident involved a traffic stop on a motorcycle with a license plate violation. A search was conducted by the Moffat County Sheriff's K-9. The K-9 gave a positive alert. During the search over two ounces of methamphetamine was located along a small amount of heroin. This individual was taken to jail and charged accordingly.

The second incident involved assisting one of our local parole officers with a check of a parolee. During the check, 42 grams of methamphetamine was located along with 7 grams of heroin. These individuals had a large sum of money in their possession.

An update on our K-9 "Bane". Bane has been riding with Officer Laehr to get use to coming to work. He is not able to be deployed yet because he is not state certified. We are looking to get Bane certified as soon as possible.

4. Investigations – Detective Sergeant Marvin Cameron

Highlighted Investigation

Members of the All Crimes Enforcement Team, the Craig Police Department, the Moffat County Sheriff's Office, as well as several Federal Law Enforcement Agencies, intercepted and participated in a controlled delivery of just over three pounds of methamphetamine to a Craig resident. A Craig resident was arrested and charged with Possession of a Controlled Substance with Intent to distribute and child abuse. This was a great example of multiple agencies working together to prevent the drugs from reaching the end user in our communities. This case is progressing through the judicial system.

- ✓ *A new cold sex assault was reported to the Craig Police Department. Investigation is on-going.*

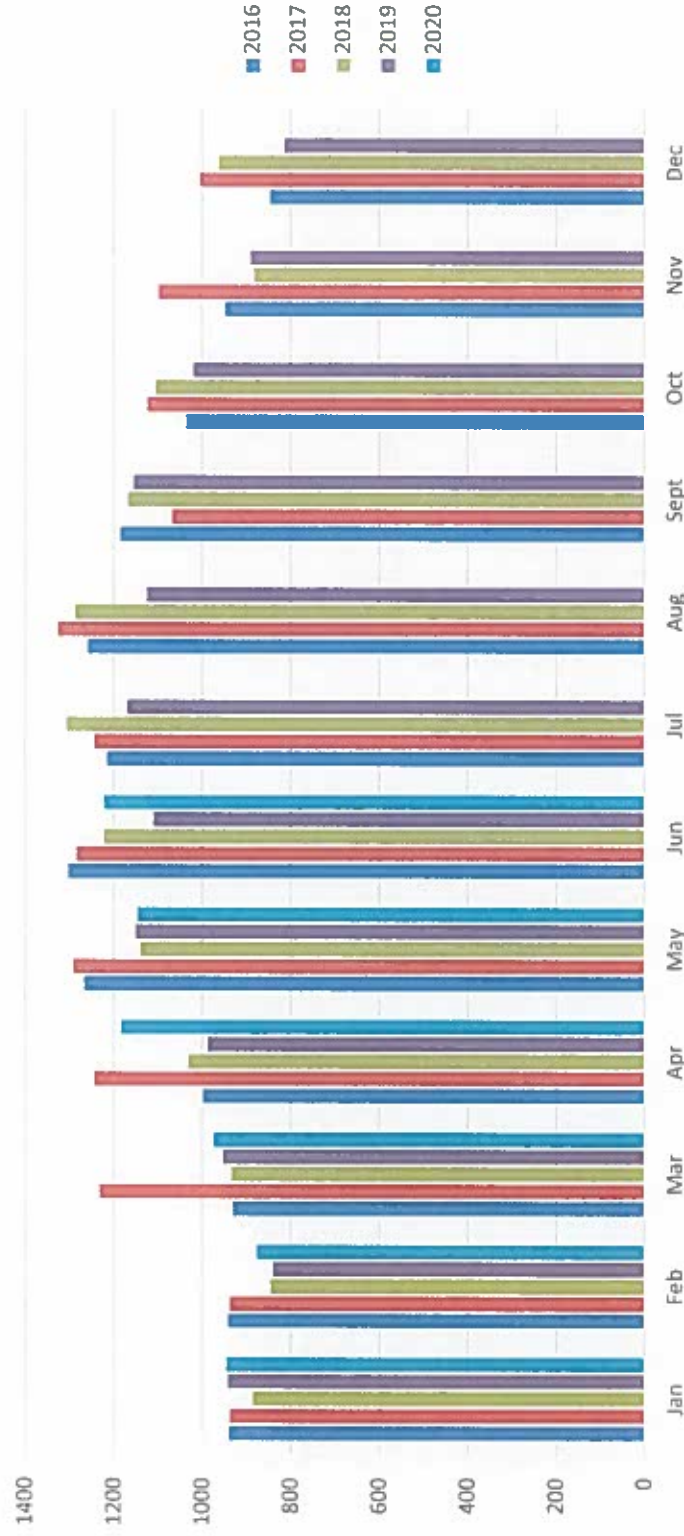
