1. *Crime and Patrol Summary*

See attachments. The department responded to 1,182 requests for service during the month of July. Community Service responded to 151 requests for service.

On July 29th, Chief DeLong and I attended a CIRSA Law Enforcement Round-Table discussion in Grand Junction. The event was attended by multiple -municipal law enforcement agencies from the Western Slope including Grand Junction Police Department, Montrose Police Department, Rifle Police Department and Meeker Police Department to name a few. The following topics were covered:

- Colorado Police Integrity Act*
- Policing in the age of Protests and Civil disobedience*
- Mental Health response by law enforcement*
- Colorado Red Flag Law*
- Body Worn cameras*
- Detention-suspicious person contacts*

This was a good presentation with very open discussions involving CIRSA attorneys and other law enforcement leaders about the many challenges facing law enforcement in Colorado. The Police Integrity Act was a hot topic. CIRSA anticipates many legal challenges and changes to this bill over the next few years. CIRSA also provided valuable resources to assist law enforcement agencies reach compliance with this act within the set timelines. Based on the discussions, I believe our agency is a bit ahead of the curve on many of the issues discussed.

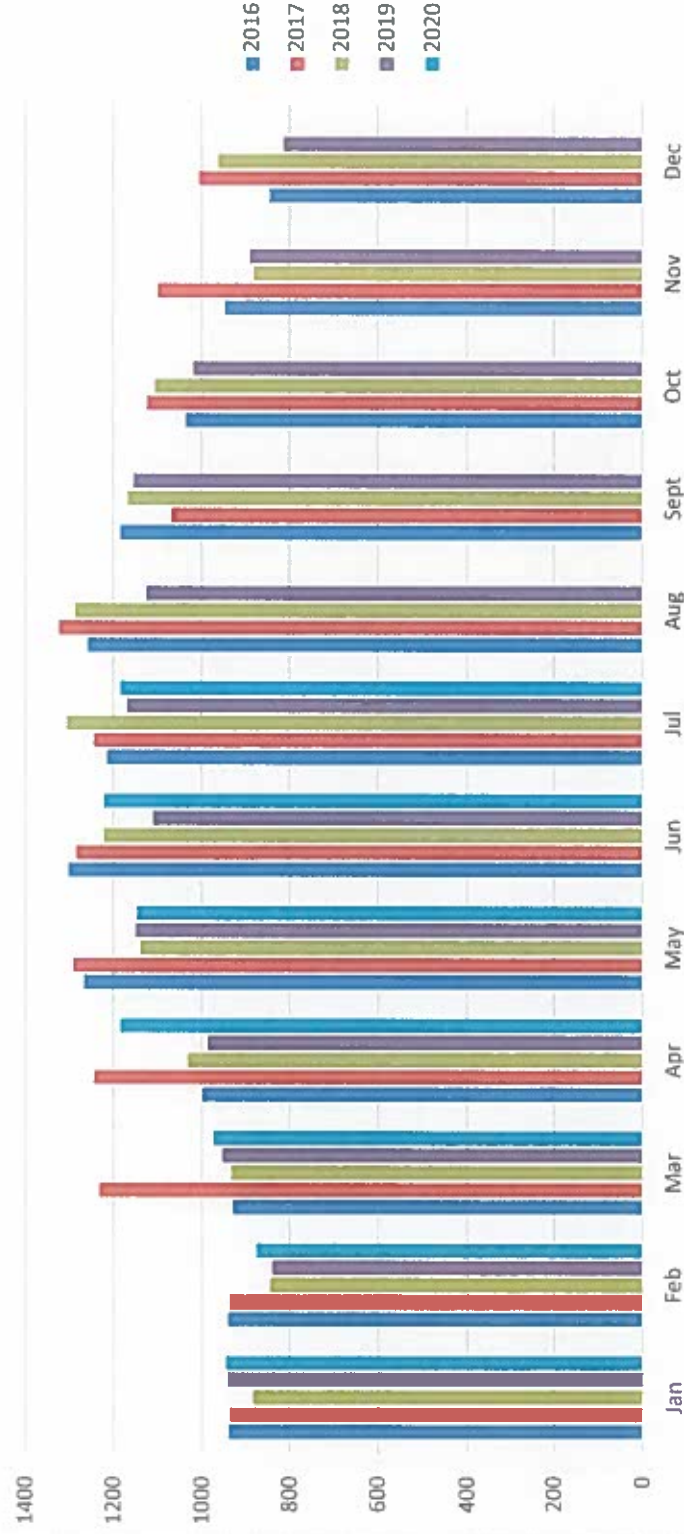
