

## CITY COUNCIL MEETING AUGUST 11, 2020 MINUTES

The second portion of Item 9J was appropriation of \$50,000 from funding allocated in the 2020 Budget for a Housing Assessment Study for development of an Urban Renewal Authority, Blight Study and Urban Renewal Authority Plan development.
