

CITY COUNCIL MEETING OCTOBER 13, 2020 MINUTES

Mayor Jarrod Ogden brought to order at 6:30 p.m. the first regular meeting of the Craig City Council for the month of October 2020. In addition to Mayor Ogden, those present were Councilmembers Chris Nichols, Andrea Camp, Ryan Hess, Paul James, Steven Mazzuca and Tony Bohrer. Staff present were City Manager Peter Brixius, Finance Director Bruce Nelson, City Attorney Heather Cannon, Police Chief Jerry Delong, Road & Bridge/Solid Waste Director Trevor Campbell, Parks and Recreation Director Ryan Dennison, Water/Wastewater Director Mark Sollenberger, Museum Director Dan Davidson, Building Official Marlin Eckhoff and City Clerk Liz White.
