You are hereby advised that an investigation has been made with regard to your application for a Retail Liquor Store license. Based on the results thereof, the following has been determined:

- 1. The location of the premises for which the license is sought is 1111 West Victory Way #135 in Craig, Colorado. Application was received on September 16, 2020.
- 2. In the two years preceding the date of the application, there has not been a denial of any liquor license application for the reason that the reasonable requirements of the neighborhood were satisfied by the existing outlets.
- 3. It appears from the application documents that you are entitled to possession of the premises where you propose to exercise the license applied for, and that the possession will continue throughout the initial term of the license, if granted.
