

CITY COUNCIL MEETING NOVEMBER 24, 2020 MINUTES

Mayor Pro Tem Bohrer brought to order at 6:30 p.m. the second regular meeting of the Craig City Council for the month of November 2020. In addition to Mayor Pro Tem Bohrer, those present were Councilmembers Chris Nichols, Andrea Camp, Steven Mazzuca and Paul James. Councilman Ryan Hess joined via ZOOM. Staff present were City Manager Peter Brixius, Finance Director Bruce Nelson. and City Clerk Liz White. Joining via ZOOM were Road & Bridge/Solid Waste Director Trevor Campbell, Parks and Recreation Director Ryan Dennison, Water/Wastewater Director Mark Sollenberger, Building Official Marlin Eckhoff, Chief of Police Jerry Delong and City Attorney Heather Cannon. Museum Director Dan Davidson and Mayor Ogden were absent.

All participated in the Pledge of Allegiance.
