

Resolution No. 6 (2021)

A RESOLUTION SHOWING SUPPORT FOR AN INTERGOVERNMENTAL AGREEMENT BETWEEN THE STATE OF COLORADO DEPARTMENT OF TRANSPORTATION AND THE CITY OF CRAIG FOR THE DEVOLUTION OF THE WEST VICTORY WAY FRONTAGE ROAD.

WHEREAS, the City of Craig has engaged with the Colorado Department of Transportation (CDOT) regarding the devolution of the CDOT owned and maintained West Victory Way Frontage Road, from just west of Vallarta's to Finley Lane and adjacent to the north side of US Hwy 40 and West Victory Way; and

WHEREAS, CDOT would relinquish all Right of Way along the Frontage Road and the City of Craig would accept ownership through an Intergovernmental Agreement (IGA), once CDOT has upgraded the Frontage Road's asphalt surface to new condition; and

WHEREAS, CDOT would internally invest funding to support construction services estimated at a value of \$223,660.00. This work would include a 2-inch mill and 2-inch asphalt overlay of the Frontage Road in its entirety. This work would be conducted in conjunction with the surface treatment job on Hwy 40 schedule to be completed by CDOT in 2022; and

WHEREAS, the City of Craig will commit approximately \$5,000.00. to complete a survey of the Frontage Road, defining the boundary of the Right of Way to be transferred from CDOT to the City of Craig upon execution of the IGA by both parties. These limits would include the Frontage Road from just west of Vallarta's to Finley Lane and from the northern boundary of the Frontage Road Right of Way to back of curb on the U.S. Hwy 40 side, to include the median surface; and

WHEREAS, the City understands that the devolution of the Frontage Road from CDOT means that all future maintenance will be conducted at the expense of the City. As a result of the Frontage Road overlay in 2022, minimal maintenance is expected during the first 8 to 10 years of ownership and the City will also collect additional HUTF dollars each successive year beginning in 2023 to help offset costs of future maintenance; and

AND WHEREAS, the transfer of the Frontage Road will allow the City to maintain minor road maintenance issues that adversely affect the businesses and their patrons having to access this roadway. The devolution, as described, will also provide a newly surfaced and attractive, functional Frontage Road for the community with minimal future expense to the City.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL FOR THE CITY OF CRAIG, COLORADO:

That the City of Craig show support for an Intergovernmental Agreement between the State of Colorado Department of Transportation and the City of Craig for the devolution of the West Victory Way Frontage Road.
