## **DESCRIPTION OF PROPOSED SOLUTION**

We propose to remove the existing sign faces, extend existing frame work to the heights required for a structurally sound base for the attachment of the new faces. In our renderings provided within this packet, we show the extension pieces that will be added to facilitate this. These additional components will be welded by our on staff welder to insure safe and secure attachments. All added components will be painted to match existing colors. New faces will be attached using stainless steel fasteners to assure permeant and rust free attachment. The renderings provided in this packet will describe the 2 options that we are offering to the City. Each of these call out sizes and materials to be used to complete this project.

## **UNIQUE OR DISTINCTIVE FEATURES**

We will call on our vast experience of various personnel within our company to design, fabricate and install this project. Some of this information can be considered as proprietary to us. 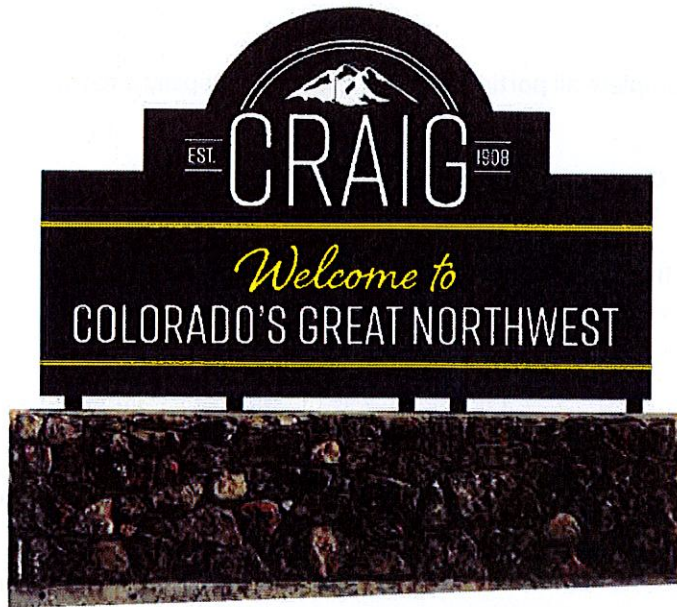
## **GENERAL COMMENTS**

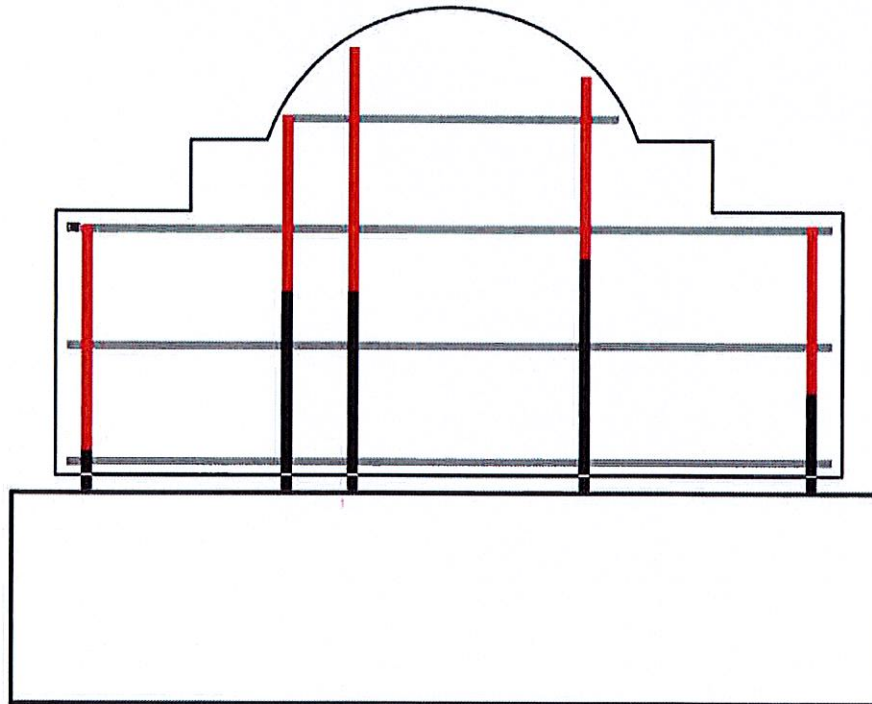
## **PROJECT SCHEDULE AND PRICING**

Our schedule will include a completion of the project within 6-8 weeks from the notice to proceed. Following this notice, we will prepare all final renderings and art work and present them to the City for final approval. Following this approval, we will begin the fabrication and vinyl production and application processes. We plan to arrive in the City early in the week, remove the existing faces, modify and paint the structures to fit the option chosen by the City, and install the new faces. Our planned timeline would have us in town for approximately 3-4 days.

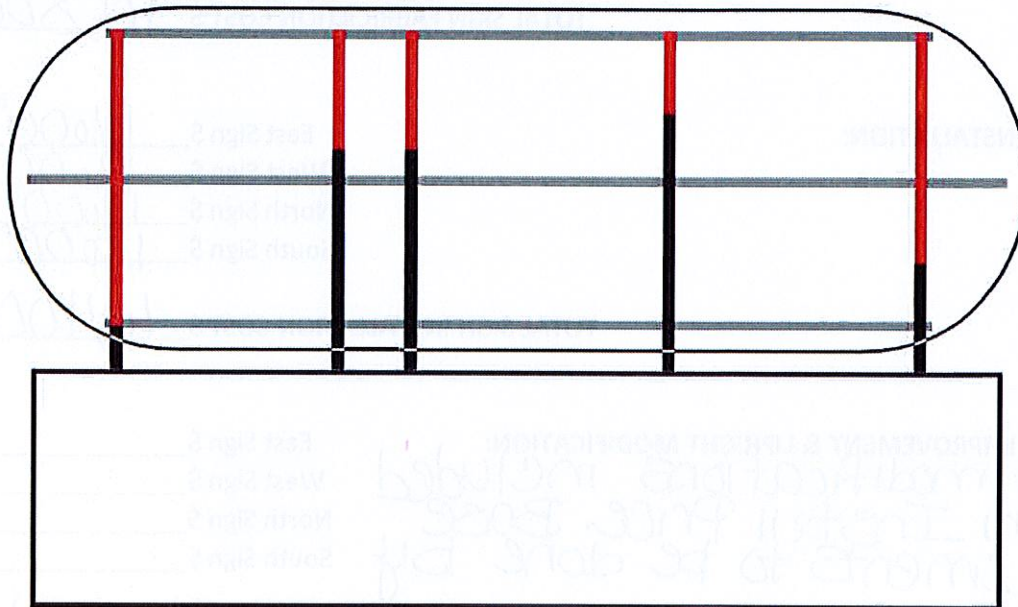
