

COUNCIL MEETING MAY 25, 2021 MINUTES

Mayor Pro Tem Steven Mazzuca brought to order at 6:30 p.m. the second regular meeting of the Craig City Council for the month of May 2021. In addition to Mayor Pro Tem Steven Mazzuca, those present were Councilmembers Chris Nichols, Ryan Hess, Paul James, and Bruce Cummings. Staff present were City Manager Peter Brixius, Finance Director Katy Burns, City Attorney Heather Cannon, Road & Bridge/Solid Waste Director Trevor Campbell, Water/Wastewater Director Mark Sollenberger, Museum Director Dan Davidson, and Deputy City Clerk Gina Duran.

All participated in the Pledge of Allegiance.

Councilman James moved with a second by Councilman Hess to approve the minutes from the May 11, 2021, council meeting. Ayes: 5. Nays: 0. Motion carried.

Councilman James moved with a second by Councilman Nichols to approve the payment of bills through May 21, 2021, in the amount of \$262,380.88. Ayes: 5. Nays: 0. Motion carried.

Councilman Cummings moved with a second by Councilman James to approve the agenda with the following amendments: remove item 9D and change NWCEDC to NWCDC. Ayes: 5. Nays: 0. Motion carried.

Public Comment was given by residents Kendre DiPietro via ZOOM, Mardi Anson, Jayne Morley, Nick Scheller, Vicki Huyser, Harold Rollins, Tammy Villard, Johnny Long and Vicki Burns.

Todd Ipsen with the Colorado Department of Transportation (CDOT) presented information regarding the bike lane on Victory Way (US Highway 40) to improve multimodal transit through Craig, CO, and tie into future pedestrian transit on Ranney Street.

Dan Davidson with the Museum of Northwest Colorado presented the 5-year action plan and budget for the Museum.

Councilman Nichols moved with a second by Councilman Hess to approve the consent agenda as presented for the renewal for a Retail Liquor Store License for Gillam Inc. dba Stockmen's Liquor located at 574 Pershing Street, Craig. Ayes: 5. Nays: 0. Motion carried.

Mayor Pro Tem Mazzuca closed the regular session and opened the Public Hearing session to discuss Item 8A- Resolution No. 13 (2021) \sim a resolution approving CDOT's striping plan for 2022 in response to the City of Craig's request and subsequent public hearing regarding the addition of a bike lane on Victory Way from Washington street to Taylor Street.

The Public Hearing was now open for public comment.

Mayor Pro Tem Mazzuca read a public comment provided by email from resident Amber Delay. Public Comment was also given by residents Tammy Villard, Jayne Morley, Vicki Huyser, and Nick Scheller.

Being no further public comment, Mayor Pro Tem Mazzuca closed the Public Hearing session and entered back into the regular session.
