A RESOLUTION APPROPRIATING ADDITIONAL SUMS OF FUNDS IN THE VARIOUS FUNDS, IN THE AMOUNT OF \$98,750 AND FOR THE PURPOSE AS SET FORTH BELOW, FOR THE CITY OF CRAIG, COLORADO, FOR THE 2021 BUDGET YEAR

WHEREAS, the City Charter (Art. VII, Part I, Sec. 14) provides for the appropriating of excess revenues exceeding budget estimates for expenditures during the budget year; and

WHEREAS, the City Council has previously adopted the 2021 Annual Appropriation Ordinance #1118 with supplemental Appropriation Ordinance #1121, and Resolutions 10(2021), 14(2021), and 18(2021); and

WHEREAS, the City Council is desirous to modify and amend the 2021 Budget to provide for funds for a one-time employee bonus of \$1,000 with mandated withholdings for all permanent employees.
