

COUNCIL MEETING DECEMBER 14, 2021 MINUTES

Mayor Ryan Hess brought to order at 6:30 p.m. the first regular meeting of the Craig City Council for the month of December 2021. In addition to Mayor Hess, those present were Councilmembers Chris Nichols, Sean Hovorka, Jesse James Jackson and Steven Mazzuca. Staff present were City Manager Peter Brixius, Finance Director Katy Burns, City Attorney Heather Cannon, Police Chief Michael Cochran, Economic Development Manager Shannon Scott, Road & Bridge/Solid Waste Director Trevor Campbell and City Clerk Liz White. Councilmembers Bruce Cummings and Paul James were absent.

Residents Jayne Morley, Vicki Huyser, James Mathey and Mark Parchman gave Public Comment.

Economic Development Manager Shannon Scott gave her 4th quarter and year-end report for 2021.

City Manager Brixius updated the group on meetings he attended or will be attending soon along with various project updates. Kudos were given to HR/Personnel staff for their efforts in implementing the safety/training programs which helped in the reduction of the 2022 Workers' Compensation premiums by \$50,000. Kudos to Melanie Kilpatrick for her efforts in producing the Police Recruit flyer.

City Councilmembers discussed various meetings and events in which they participated in or will take place soon.
