

## COUNCIL MEETING JANUARY 25, 2022 MINUTES

Mayor Ryan Hess brought to order at 6:30 p.m. the second regular meeting of the Craig City Council for the month of January 2022. In addition to Mayor Hess, those present were Councilmembers Chris Nichols, Sean Hovorka and Jesse James Jackson. Staff present were City Manager Peter Brixius, Finance Director Katy Burns, City Attorney Heather Cannon, Economic Development Manager Shannon Scott, Water/Wastewater Director Mark Sollenberger, Road & Bridge/Solid Waste Director Trevor Campbell, Building Official Marlin Eckhoff and City Clerk Liz White. Councilmembers Bruce Cummings, Paul James and Steven Mazzuca were absent.

All participated in the Pledge of Allegiance.

Councilman Hovorka moved with a second by Councilman Nichols to approve the Consent Agenda as presented. It included the approval of the minutes from the January 11<sup>th</sup> council meeting as well as approval of the bills through January 20, 2022 in the amount of \$425,917.33 and bills through December 31<sup>st</sup>, 2021 in the amount of \$76,990.90.
