

## COUNCIL MEETING MARCH 28, 2023 MINUTES

Mayor Ryan Hess brought to order at 6:30 p.m. the second regular meeting of the Craig City Council for the month of March 2023. In addition to Mayor Hess, those present were Councilmembers Chris Nichols, Sean Hovorka, Jesse James Jackson, Derek Duran and Paul James. Staff present were City Manager Peter Brixius, Finance Director Katy Burns, City Attorney Heather Cannon, Building Official Marlin Eckhoff and City Clerk Liz White.

All participated in the Pledge of Allegiance.

City Clerk Liz White took councilmember roll call. Those present were Councilmembers Chris Nichols, Sean Hovorka, Jesse James Jackson, Derek Duran, Paul James and Mayor Ryan Hess. Councilmember Tom Kleinschnitz was absent. Councilman James moved with a second by Councilman Hovorka to excuse the absence of Councilman Kleinschnitz. Ayes: 6. Nays: 0. Motion carried.

Councilman Hovorka moved with a second by Councilman Duran to approve the Consent Agenda as presented that included the approval of the minutes from the March 14<sup>th</sup> council meeting as well as approval of the bills through March 24, 2023, in the amount of \$462,890.41. Ayes: 6. Nays: 0. Motion carried.

Councilman James moved with a second by Councilman Hovorka to approve the agenda as presented. Ayes: 6. Nays: 0. Motion carried.

City Manager Brixius updated the group on current and future meetings and projects.

City Councilmembers discussed various meetings and events in which they participated in or will take place soon. Councilman Hovorka resigned from City Council effective March 28, 2023.

Public comments were given by Ken Wergin, Ethan Leiberman, Vicki Huyser, Trina Tousley and Jessica Foberg.

Mayor Hess closed the Regular Session and moved into Public Hearing.
