RESOLUTION No. 14

Canceling Declaration of Local Disaster for the City of Craig

WHEREAS, expected flooding as a result of heavy snowfall and anticipated high temperatures did not occur,

AND WHEREAS, these anticipated circumstances did culminate in costs associated with preparing for the potential of flooding,

AND WHEREAS, the potential flooding expected from the local river and creeks reaching and exceeding their channel flow capacity was not realized, with only minor damage incurred closer to the main channel for which we may pursue reimbursement, to include the cost of implementation of preventative mitigation steps,

AND WHEREAS, the preventative mitigation steps and disaster preparation training and orientation required to qualify for cost reimbursement resulted in most of the documented cost incurred by the City,

AND WHEREAS, Craig and Moffat County will continue to accrue and submit costs for reimbursement associated with the implementation of these mitigation steps until the disaster declaration is canceled, providing Governor Polis determines that the statewide efforts and costs in 2023 meet the necessary threshold for reimbursement and declares a disaster emergency for Colorado,

AND WHEREAS, the nature and gravity of the initial declaration required swift action and did not allow for formality of resolution and ordinance,

AND WHEREAS, the nature and gravity of the cancelation of the emergency declaration does not require such swift action and should initially be approved by the Craig City Council through this Resolution,

I DO HEREBY DECLARE, pursuant to the State Constitution, the Colorado Disaster Emergency Act (C.R.S. 24-33.5-701, et seq.), the Charter and Ordinances of the City of Craig, that a **STATE OF LOCAL DISASTER EMERGENCY** is **CANCELED** in and for the City of Craig and now exists as so ordered, authorized, and approved.

BE IT KNOWN THAT the geographic area affected and to which this DECLARATION applied is known as the City of Craig.

AND BE IT ALSO KNOWN THAT the Craig City Council authorized the City Manager to hereby advise the Governor of the State of Colorado and the population within the aforementioned described area that a STATE OF LOCAL EMERGENCY no longer exists as allowed by the State Constitution, the Colorado Disaster Emergency Act (C.R. S. 24-33.5-701, et seq.), the Charter and Ordinances of the City of Craig,

AND BE IT ALSO KNOW THAT this DECLARATION and STATE OF LOCAL DISASTER EMERGENCY is no longer in force as of July 11, 2023, and as approved by the Craig City Counsel,

AND THAT, this Disaster Declaration shall be promptly canceled and filed with the Moffat County Clerk and Recorder and with the Office of Emergency Management.

AND THAT, this Resolution and Declaration is necessary for notification and the welfare of the citizens of the City of Craig, State of Colorado.
