

## **ORDINANCE NO. 1146 (2023)**

### **AN ORDINANCE AMENDING SECTION 12.04.030 OF THE CRAIG MUNICIPAL CODE TO REQUIRE 72 HOURS NOTICE PRIOR TO THE COMMENCEMENT OF ANY WORK UNDER THE PROVISIONS OF CHAPTER 12**

WHEREAS, the City of Craig is a home rule municipality;

WHEREAS, the City requires advance notice to be given to the city engineer prior to the commencement of any work pursuant to Chapter 12;

WHEREAS, the City has previously required that twenty-four (24) hours advance notice be given to the city engineer prior to the commencement of any work pursuant to Chapter 12;

WHEREAS, the City Council determines that it is in the best interest of the City of Craig to require seventy-two (72) hours' notice to be given in advance of the commencement of any work pursuant to Chapter 12;

AND WHEREAS, the City Council agrees it is necessary for the preservation of the general welfare of the people of the City of Craig to modify the Code as follows.

**NOW THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL FOR THE CITY OF CRAIG, COLORADO:**

Section 1. Section 12.04.030 of the Craig Municipal Code is hereby amended as follows:

12.04.030 - Requirements.

All cuts, openings, holes, curb cuts and excavations shall be made in accordance with the "City of Craig Standards and Specifications." The city engineer shall be given seventy-two (72) hours' notice prior to the commencement of any work under the provisions of this chapter.

Section 2. If any subsection, sentence, clause, or phrase of this ordinance is for any reason held to be invalid, such decision shall not affect the validity of the remaining portion of this Ordinance. All other provisions of Title 12 of the Craig Municipal Code shall remain in full force and effect.

Section 3. The City Council deems it appropriate to publish the title of this ordinance, together with a summary of the ordinance and with a statement that the text is available for public inspection and acquisition in the office of the City Clerk.

Section 4. This ordinance shall be effective immediately upon passage.

Section 5. This Ordinance is enacted pursuant to the City's authority to act under its police power to protect and preserve the general welfare of the City and its citizens.
