

COUNCIL MEETING OCTOBER 24, 2023 MINUTES

Mayor Derek Duran brought to order at 6:30 p.m. the second regular meeting of the Craig City Council for the month of October 2023. In addition to Mayor Duran, those present were Councilmembers Chris Nichols, Vicki Huyser, Jesse James Jackson, Randy Looper and Tom Kleinschnitz. Staff present were City Manager Peter Brixius, City Attorney Heather Cannon, Interim Finance Director Bruce Nelson, Senior Account Amanda Tomlinson, Parks and Recreation Director Ryan Dennison and City Clerk Liz White.

All participated in the Pledge of Allegiance.

City Clerk Liz White took councilmember roll call. Those present were Councilmembers Chris Nichols, Vicki Huyser, Jesse James Jackson, Randy Looper, Tom Kleinschnitz and Mayor Derek Duran.
