

RESOLUTION NO: 26 (2023)

A RESOLUTION APPROVING THE AGREEMENT BETWEEN THE CITY OF CRAIG/MOFFAT COUNTY AND OLDCASTLE SW GROUP INC. DBA UNITED COMPANIES FOR THE REHABILITATION OF MOFFAT COUNTY AIRPORT RUNWAY 7/25 AND TAXIWAY CONNECTORS, AND REPLACEMENT OF RUNWAY LIGHTING

WHEREAS, C.R.S. §29-1-203 provides authority for Governments to cooperate or contract with one another to provide any function, service, or facility lawfully authorized in Colorado, and;

WHEREAS, the City of Craig and Moffat County jointly sponsored a grant request for Federal Assistance through the Federal Aviation Administration (FAA) for rehabilitation of the Moffat County Airport Runway 7/25 replacement of runway lighting and were awarded Five Million Nine Hundred and Twenty-Two Thousand Four Hundred and Sixty Dollars (\$5,922,460.00) from the FAA along with an award from the Colorado Department of Transportation (CDOT), Funding Six Hundred and Fifty Thousand (\$650,000) for rehabilitating taxiway connectors;

WHEREAS, the City of Craig and Moffat County will equally share in a Local Match for the project totaling Four Hundred and Fifty-Two Thousand, Four Hundred and Ninety-Five Dollars (\$452,495.00). The total construction award for the project is Six Million Six Hundred and Twenty-Eight Thousand and Fifty-Two Dollars and Seventy-Five Cents (\$6,628,052.75);

WHEREAS, the City of Craig has approved a Fiscal 2024 budget allocation for the airport rehabilitation local match totaling Two Hundred and Twenty Six Thousand Two Hundred and Forty Seven Dollars and Fifty Cents, (\$226,247.50);

WHEREAS, the City of Craig and Moffat County agree to enter into the Agreement with United Companies to complete the rehabilitation of Moffat County Airport Runway 7/25 and taxiway connections, and replacement of runaway lighting. The Agreement is attached to this resolution as Exhibit A;

NOW THEREFORE BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF CRAIG:

1. The City of Craig, as co-sponsors with Moffat County, is authorized to enter the Agreement with United Companies, marked as Exhibit A, for the benefit of the citizens of the City of Craig.

2. Rehabilitation of the Moffat County Airport runway 7/25 and taxiway connections, and replacement of runway lighting is currently necessary. Accordingly, all actions taken pursuant to the Agreement by the officers, employees and agents of the City related to this Agreement are approved and confirmed.
