SUBJECT: Award of Bid for 2024 Vehicle Upfit and Vehicle Purchase

In our 2024 budget, council approved \$41,000.00 for vehicle upfit. I have solicited BID's from numerous upfitters, and have received the following returns:

Within our 2024 budget, Council approved the purchase of three (3) new vehicles and a budget of \$156,700.00.

Last year, we attempted soliciting bids for our purchasing of vehicles but, were notified local dealers could not obtain the vehicles, with one dealer stating he could obtain again in 2025. With this information we reached out to Colorado state bid holders and learned all orders had already been taken. I then reached out to Brannen Motors located in Georgia who fulfilled our 2023 purchases.
