

RESOLUTION NO. 8 (2024)

A RESOLUTION DESCRIBING THE PURPOSE OF A DONATION TO THE YAMPA VALLEY GOLF ASSOCIATION, INC. (YVGA) FOR THE A PURCHASE OF A FAIRWAY MOWER

WHEREAS, the City of Craig's City Council has budgeted for a donation in fiscal year 2024 in the amount of \$50,000 for the YVGA to acquire a new fairway mower for ongoing course maintenance, and;

WHEREAS, the City of Craig and Moffat County have historically provided financial contributions for the golf course and historically supported the formation of a governing board for the purpose of determining an annual budget, operations and maintenance costs and capital improvement needs necessary to keep the golf course in excellent condition, and;

WHEREAS, the City of Craig is interested in seeing the golf course well maintained and professionally groomed for the purpose of attracting members, players and events to the golf course as a benefit to the community's economic development efforts, primarily focused on supporting the needs of the golf course, the airport, Craig's hospitality industry and Craig's local economy, and;

WHEREAS, the impact of this new equipment will improve the efficiency of the maintenance crew working at the golf course to ensure that the fairways meet the expectations of all golf course users playing at the Yampa Valley Golf Association course, and;

WHEREAS, the Craig City Council has received documentation of the acquisition of a fairway mower and proof of payment from the golf course to John Deere in the amount of \$51,126.50, and;

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL FOR THE CITY OF CRAIG, COLORADO, AS FOLLOWS:

The City Council has determined that YVGA's request for donation is reasonable and appropriate for the ongoing benefit of the Citizens of Craig and Moffat County and for the improvement of operations and maintenance at the golf course.

This Resolution shall take effect upon adoption, shall be authenticated, and shall be numbered and recorded in the official records of the City.

If any provision of this resolution or the application of it to any person or circumstance is held invalid by a court of competent jurisdiction, such invalidity shall not affect other provisions or applications of this resolution which can be given effect without the invalid provisions or applications. The provisions of this resolution are expressly declared to be severable.
