Ballot Measure 2A:

SHALL CITY OF CRAIG TAXES BE INCREASED BY \$100,000.00 ANNUALLY IN THE FIRST FULL FISCAL YEAR BEGINNING JANUARY 1, 2021 AND SUCH AMOUNTS COLLECTED IN FUTURE YEARS BY IMPOSING AN ADDITIONAL SALES TAX ON THE PRICE PAID ON THE SALE OF RETAIL MARIJUANA AND MARIJUANA PRODUCTS WITH THE RATE OF SUCH ADDITIONAL SALES TAX BEING ALLOWED TO BE DECREASED OR INCREASED BY THE CITY COUNCIL WITHOUT FURTHER VOTER APPROVAL SO LONG AS THE RATE DOES NOT EXCEED FOUR (4%) PERCENT; AND WITH THE RESULTING TAX REVENUE BEING ALLOWED TO BE COLLECTED AND SPENT NOTWITHSTANDING ANY LIMITATIONS CONTAINED WITHIN ARTICLE X, SECTION 20 OF THE COLORADO CONSTITUTION OR ANY OTHER SPENDING, REVENUE RAISING, OR OTHER LIMITATIONS PROVIDED BY LAW;

WITH THE TAX REVENUES FROM THE ADDITIONAL SALES TAX BEING COMMITTED AND USED BY THE CITY TO FUND THE EXISTING MOFFAT COUNTY LIBRARY (CRAIG BRANCH) AND EXISTING MUSEUM OF NORTHWEST COLORADO IN CRAIG FOR FIVE (5) BUDGET YEARS?

Ordinance No 1123 is Killed by City Council

After a presentation by the Moffat County
Library Board Members for funding, Craig City
Council votes to kill
Ordinance No 1123 to implement additional sales tax of 2% on marijuana sales. Motion carries.

Councilman James moved with a second by Councilman Hess to kill Ordinance No 1123 (2021) ~ an ordinance of the City of Craig, Colorado implementing the additional sales tax of 2% on retail marijuana sales approved in Ordinance No. 1098 (2019) and allocating the revenue received between the Moffat County Library and the Museum of Northwest Colorado. Ayes: 4. Nays:3. Motion carried.

Craig Branch is able to open on Fridays

Grant Money

Available grants are for materials, programming, capital expenses. Grant money can **not** be used for operating expenses (such as staffing).

Volunteers

Although the library appreciates all of their volunteers; volunteers can **not** be used to **staff** the library.



Dinosaur Branch

Moffat County Libraries has a branch in Dinosaur, CO.

The Town of Dinosaur budgets \$15,000 annually for their branch to allow additional hours to keep branch open.

This is approximately 0.4% of their overall town budget.

Craig Branch

In order to return to full time operation in Craig, the library board requests 2 additional part time staff members for the Craig Branch with a 5 year commitment.

This would require a \$30,000 to cover personnel costs for 2025.

Craig Branch would be able to open Monday through Saturday 10:00AM - 6:00PM (full time).

This is approximately 0.07% of the City of Craig's budget (based on the 2024 budget).

Safeguards Presented by Library in 2021*


Inter Governmental Agreement:
