



**COUNCIL MEETING
SEPTEMBER 10, 2024
MINUTES**

Mayor Chris Nichols brought to order at 6:30 p.m. the first regular meeting of the Craig City Council for the month of September 2024. In addition to Mayor Nichols, those present were Councilmembers Michelle Gottschall, Derek Duran, Jesse Jackson, Randy Looper, Andrea Camp and Luke Tucker. Staff present were City Manager Peter Brixius, City Attorney Heather Cannon, Finance Director Mindy Elliott, Police Chief Michael Cochran and City Clerk Liz White.

All participated in the Pledge of Allegiance.

City Clerk Liz White took councilmember roll call. All council members were present.

Councilman Looper moved with a second by Councilman Duran to approve the Consent Agenda as presented which included the approval of the minutes from the regular council meeting on August 27, 2024. City Manager Brixius updated the group on current and future meetings and projects.
