### RETAIL MARIJUANA AND MARIJUANA PRODUCTS SALES TAX

SHALL CITY OF CRAIG TAXES BE INCREASED AND REVIEWED ON AN ANNUAL BASIS BEGINNING JANUARY 1, 2026 AND SUCH AMOUNTS COLLECTED IN FUTURE YEARS WITH THE OPTION OF IMPOSING AN ADDITIONAL SALES TAX ON THE PRICE PAID ON THE SALE OF RETAIL MARIJUANA AND MARIJUANA PRODUCTS WITH THE RATE OF SUCH ADDITIONAL SALES TAX BEING ALLOWED TO BE DECREASED OR INCREASED BY THE CITY COUNCIL WITHOUT FURTHER VOTER APPROVAL SO LONG AS THE RATE DOES NOT EXCEED A CAPPED AMOUNT OF FOUR (4%) PERCENT; AND WITH THE RESULTING TAX REVENUE BEING ALLOWED TO BE COLLECTED AND SPENT NOTWITHSTANDING ANY LIMITATIONS CONTAINED WITHIN ARTICLE X, SECTION 20 OF THE COLORADO

CONSTITUTION OR ANY OTHER SPENDING, REVENUE RAISING, OR OTHER LIMITATIONS PROVIDED BY LAW; WITH THE TAX REVENUES FROM THE ADDITIONAL SALES TAX BEING
