Facility Rules

Admission:

- Admission to pool shall be refused to all persons having any contagious disease or infectious condition.
- Staff reserves the right to inspect all coolers for items not allowed within the facility.
- Persons under the influence of alcohol or exhibiting erratic behavior will not be admitted, or asked to leave.
- No use of nicotine or tobacco products allowed within 100 feet of facility.
- Weapons, alcohol, illicit drugs, e-cigarettes, are NOT ALLOWED!
- No glass containers are allowed.
- Non-toilet trained children must wear reusable swim diapers.
- Children under 10 years of age MUST be accompanied by an adult, or someone 18 or older at all times.
- Parents and guardians are responsible for minors in their care while in the facility.
- Jeans, cut-offs, heavy clothing, regular diapers, dirty clothes, or shoes, are not allowed in either pool.
- As this is a family facility, family friendly swimwear is required. Private and personal body parts must always be covered.
- Pool passes are only valid for those immediate family members listed on the actual pass.
- It is recommended that groups having over 10 persons, notify the manager 7 days in advance or risk being turned away. This allows for adequate staffing.
- Children under 12 years of age must leave the facility at 5:00 p.m., unless accompanied by an adult 18 or older.

Facility Operations:

- The pool management has the authority to implement and enforce rules that are more stringent or that supplement those listed here with no notice.
- No swimming or pool usage without certified lifeguard on deck.
- Patrons must shower prior to entering the pools, per state regulations.
- Pools may be cleared due to weather conditions. Patrons must seek shelter under awnings or in the building.
- Swimming is prohibited when lightning is present. The "all clear" signal will be given after 30 minutes without any sighting of lightning or sound of thunder.
- NO REFUNDS WILL BE GIVEN DUE TO INCLEMENT WEATHER.
- No new admissions will be sold while the facility is closed for weather conditions.
- The facility will not open unless air temperature is a minimum of 65 degrees Fahrenheit.
- The City of Craig is not responsible for lost or stolen items. Coin lockers are available for use.
- Emergency gates are to remain free from persons and/or objects during all hours of operation.
- Sidewalks in front of building are to remain free of bikes, and other objects. Please use bike rack provided.
- There is a 30-minute facility break at 3:00 p.m. each day. Everyone under 18 years of age must exit the pools. Adults over 18 may swim at this time. The break ends at 3:30 p.m., at which time, everyone will be allowed back into the pools.

Facility Rules

- Appropriate social behavior, treatment of others, and care for property is expected of all employees, patrons, and program participants.
- Any physical, mental, verbal, or emotional mistreatment of oneself or other and/or any intentional damage, vandalism, or theft, or mistreatment will not be tolerated and may result in loss of membership or future visits to the facility.

General Pool Use:

- No running within the facility is allowed.
- No extended or repetitive underwater breath holding, or hypoxic training is allowed.
- Swimmers under the age of 18 will be swim tested for ability and must stay in areas of pool according to skill level. The American Red Cross competency test will administered by a staff member.
- Dive only in designated areas.
- Chicken fights, launching, and other risky activities are not allowed.
- Ball playing and acrobatics are not allowed within the facility. This includes the lawns.
- Only Type II and III United States Coast Guard (USCG) approved flotation devices are allowed, as well and USCG approved "puddle jumpers". These devices **MUST NOT** have been used in any water except chlorinated swimming pools, as this transfers bacteria and other organisms. These devices must be properly fit on the person.
- **Children using a Personal Flotation Device (PFD) must remain within arm's reach of an adult or parent when in the water, deeper than swimmer's arm pits. Adult must be in the pool with the non-swimmer.**
- Balls and water toys can be used at the staff's discretion.
- Snorkels and masks that cover the nose are not allowed.

Wave Pool Rules:

- Swimmers must enter from the shallow end.
- Swimmers must exit from shallow end or ladder.
- Swimmers under age 18 are required to take a swim test, to determine swimming ability and if they can safely go past the black line. The swim test is the American Red Cross Water Competency to determine level of ability. These tests are performed by staff, and patrons are only allowed to take the test once per day.
- Rental tubes are for use by swimmers and non-swimmers with adult supervision. They are **NOT A LIFESAVING DEVICE**.
- Tubes that are being misused may be confiscated at staff discretion.
- Only rental tubes allowed.
- Limit of 2 people per tube maximum.
- Standing on tubes is not permitted.
- No stacking of tubes in or out of the water is permitted.
- Jumping in, on, or through the tubes from the side of the pool is not allowed and very dangerous.
- No run and plunge entries are allowed.
- Swimmers in PFD's must remain behind the black line in the shallow part of the pool, during the wave cycles.

Facility Rules

Tot Slide Rules:

- The Tot slide is for children 6 years and younger.
- Children must be supervised at all times.
- Only a front facing seated position is permitted.
- One child at a time on the slide, including the steps.
- Children wearing PFD's must have an adult in water to catch them.

Diving Board and Slide Rules:

- Check the area in front of the board/slide before entering. Do not enter until the person ahead of you has safely reached the side of the pool.
- Only one person allowed on the board/slide at a time, including the steps.
- Only one bounce on the board.
- After water entry, immediately swim to the closest side and exit the water. Do not cross the pool in front of the other amenity.
- Cartwheels, handsprings, seat drops, or other stunts are not allowed.
- No stopping or slowing down in the slide.
- No going down the slide backwards.
- No swimming in the diving well is allowed.
- A swim test is required to use the board and deep end slide. Swim test will be administered by pool staff.
- No patron will be allowed to be caught in the water after jumping from the board.
- No PFD's may be worn when using diving board and slide.
