***Fee**

Two State-mandated education-fund fees totaling \$5.00 are included in each food service establishment license fee (effective 11/08/00)

****Non-Profit**

Charitable, religious, fraternal, service, civic, or other nonprofit organizations are exempt from state surcharge, provided that they can furnish, to the local health department, evidence of their tax-exempt status.

(Non-Profit Organizations are listed at the exempt amount: DO NOT REDUCE FEE)

*****Surcharge**

A \$100 surcharge is added after the 3rd event of the calendar year (if establishment could be permanently licensed). Does not apply to low risk temporary food licenses.

Applications are due on April 30th of each year. There will be a 50% late filing fee for applications RECEIVED after April 30th of each year. Applicants will be notified by certified mail if their applications are received after the deadline.
