Ms. Manning,

In accordance with Chapter 143.034, please consider this my written request to appeal the below questions for the City of Desoto Firefighter Driver - promotion exam held on May 6, 2024.

Test Question #23

As stated on page 55 in the Building Construction textbook, the NFPA is an organization that performs fire-resistance testing. There are several other references of significant evidence throughout the text, as well.

Test Question #46

The definition given was not adequately conveyed from book to test. No where in the question did it reference Tandem Pumping and short relay operations being a form of relay operations. The question merely asked - I paraphrase - a pumper directly connected to a water supply source pumping water to the second engine.

In Dual pumping the second pumper receives water from the first, as well. The question was not specific nor clear enough, on what was being asked.

Test Question #56

As I selected, a Voltmeter is used to check the battery's condition, unlike an Ammeter that checks the condition of the alternator.

Test Question #62

In this question, unlike so many others, there was no page number of reference to where it was pulled in the cited material. The answer being on page 19 of the Desire to serve book specifically lays out the pragmatic questions of Robert Greenleaf.

Test Question #94

As stated in SOP's 211 -

Intermediate Firefighter - \$50.00, Advanced Firefighter - \$50.00, Master Firefighter - \$50.00. Each step is \$50 increments added. Therefore if you were an Advanced Firefighter, you would be receiving a total of \$100. \$50 for Intermediate and \$50 for Advanced. The question did not ask how much the step up was from the Intermediate or what the increments were. Rather, it asked how much pay an Advanced Firefighter would receive, which is \$100.

Please let me know if I need to further clarify anything above.
