- 1. Conduct a Public Hearing and consider Ordinance rezoning properties within the new "Hampton Road Character Code" zoning area. The properties within the "Hampton Road Character Code" zoning area will be rezoned from their current multiple zoning districts to the following five (5) new zoning districts: 1. Urban Center, 2. Urban General, 3. Neighborhood Services, 4. Urban Neighborhood and 5. Neighborhood Transition. The applicant is the City of DeSoto.(Case #Z-1514-24)
- 2. The U-Haul properties consist of approximately 6.33 acres of land legally described as Tract 11 and Tract 12, Block A, James Porter Survey, Abstract No. 1129 and Lots 9RR and 9RR.1, Block A, Meadow Acres/U-Haul Addition. (Case No. Z-1517-23)
