IV. Review B-1 Code

The commission reviewed the draft of ordinance to amend §110-610 Downtown Business District B-1 code. Example: (4) Living and/or sleeping quarters shall be permitted use when constructed above the ground and basement floors. No living and/or sleeping quarters shall be permitted in any detached accessory building or structure on the same lot of any building. The Zoning Administrator will contact the Town Attorney with the request.
