Motion made by Mike Caccitolo to approve the increase to 20% in Corporate Bonds, seconded by Dave Dyer. A roll call followed: Ayes: Trustees Caccitolo, Dyer, Kopp, Nolte, Swanson (5) Nays (0). Motion passed.

Motion made by Dave Dyer to approve the Investment Manager's Report; seconded by Paul Nolte. A voice vote followed. Motion carried.
