On behalf of the men and women of the Elmhurst Police Department, I am pleased to present our Annual Report for 2012. We have designed this report to be a resource for municipal officials, law enforcement professionals, students, journalists and the people who live and work in the City of Elmhurst.

This Annual Report contains updated information about the many services which we provide with the City of Elmhurst. The report also contains a current employee organizational chart, a detailed description of each unit within the department, as well as specialized assignments and mutual aid participation. Also included is a statistical section which summarizes important data and identified emerging trends. I am pleased to report that overall crime in the City is down compared to year 2011, while the level of service which we provide, measured as calls for service increased by a little more than 2.8%. Of note for 2012, was a reduction in residential burglary. I attribute this reduction as a result of our focused efforts and use of technology.

The Elmhurst Police Department remains committed to excellence. I would like to extend my personal appreciation to our citizens, Acting Mayor Levin and members of the City Council, City Manager Grabowski and the employees of the Elmhurst Police Department for their continued support of professional services within our community.

2012 Elmhurst Police Department Annual Report

Executive Summary

The Police Department is pleased to report that overall crime within the City of Elmhurst fell by 17% in 2012. The 9-1-1 service call workload exceeded previous years by 2.8% returning closer to 2010 levels. In other words, police service was up and overall crime was down and overall workload slightly decreased.

While it is important to recognize general and specific crime trends, it is also beneficial to identify and assess the general components of those trends. A close examination of the statistical analysis provides great insight permitting the police department to more effectively deploy staffing and implement programs which will address the short term and long term needs of the community.

In response to the needs of our community, we took a more proactive role in responding to local and county-wide burglary trends by analyzing data and cooperating with other local police agencies. As a result of these actions, Elmhurst detectives were instrumental in the apprehension of several burglary crews. Although manpower intensive, I believe that these efforts helped to reduce the number of residential burglaries in our community.

In addition, toward the end of 2012, we more closely analyzed our crime trends and calls for service in an effort to more effectively staff personnel based on demonstrated needs rather than historical staffing. We also reviewed our policies and procedures to ensure we limit departmental liability and continue to provide the highest level of service to our community.

CALLS FOR SERVICE

Our 2012 9-1-1 calls for service increased to 16,529 from 16,075 in 2011. This represents an increase of 2.8% over 2011. We will be monitoring the calls in 2013 to determine if there are any emerging trends. The significant crime trends that we noticed in 2012 were decreases in Battery 16% and Burglary 41%.

The reported incidents of Theft decreased by 20%, Identity Theft decreased by 26% and Damage to Property decreased by 52%.

ACCOMPLISHMENTS

I am proud of the accomplishments of our staff in 2012. Throughout the year we received many letters from residents and other law enforcement agencies expressing their appreciation for quality and level of service which we provide. In addition, our employees also received letters of commendation, letters of appreciation and lifesaving awards.



Office of the Chief



The Office of the Chief consists of the Chief of Police, senior management team, and support staff. The role of this office is to provide leadership, direction and vision to the Department in the fulfillment of its overall mission. The Department is led by **Chief Michael R. Ruth** who has served as Elmhurst Police Chief since 2012. Chief Ruth brings 34 years of Law Enforcement experience to our agency. Police Administration is led by **Deputy Chief Dominic Panico** who has served since 1981. Police Operations is led by **Deputy Chief James Kveton** who has served since 1985. In addition,

providing critical support services are **Administrative Assistant to the Chief of Police Susan Duffy** and **Administrative Assistant to the Deputy Chiefs Jennifer McKeown** (*Left to Right*).









Police Operations

Patrol Division

The Patrol Division is the largest component of the Elmhurst Police Department. The Patrol Division is responsible for responding to both emergency and non-emergency calls for service from the public, handling special assignments and proactively addressing community concerns. Patrol Officers are responsible for protection of life and property, helping to maintain peace, order and safety to all, conducting preliminary investigations, enforcing the Illinois Criminal Code and traffic laws, as well as City Ordinances. The Elmhurst Police Department encourages Patrol Officers to take a proactive approach to interaction with the community. During 2012, Patrol Officers responded to 42,917 total calls for service regarding criminal offenses, traffic crashes, alarm activations, disturbances, traffic complaints, traffic stops and other miscellaneous events.

The Patrol Division is divided into three shifts in order to provide continuous 24-hour police service. Each shift is supervised by a Watch Commander, Sergeant or Officer in Charge. The Department supplements traditional patrol units with Officers trained to perform ancillary functions such as that of Evidence Technicians, Field Training Officer, Canine Officer, and DARE Officer.



Investigations Division



The Investigations Division is supervised by **Detective Commander Robert Nicholas**. It is a specialized unit staffed with law enforcement professionals who possess special skills and training, generally above that

of an average patrol officer. These special skills allow investigators to handle followup investigations and investigate crime that is complex or geographically beyond

the reach and control of patrol officers. Based on their assignment and the opportunistic nature of criminals, investigators are on call 24 hours a day, seven days a week.

The Elmhurst Police Department's Investigative staff is comprised of 5 investigators and a supervisor. The investigators share the responsibility of conducting follow-up investigations and augmenting the patrol division when needed. The investigators also conducted 44 comprehensive background checks for police and firefighter hires and liquor license

applicants. These investigators are

also assigned to the DuPage County Major Crimes Task Force (MCTF), which provides mutual aid to law enforcement in DuPage County.

In 2012, the Elmhurst Police Investigations Division reviewed 623 criminal cases. Of these 623 cases, 261 were assigned to investigators for follow-up.

School Resource Officers

The school police liaison program allows for effective communication between the schools and police department. In the past, identifying a contact person at the school level who was willing and able to communicate needed information to the police was difficult. Officers assigned to work with juveniles and in a school setting are more likely to be effective when provided with structured access to the school. It is also clear that the visible presence of a police officer is a

deterrent to criminal actions and is likely to have an impact on crime and related problems. In addition, when a crime does occur, there is a significant reduction in response time, a critical solvability factor, thereby minimizing the impact of the crime on the victim as well as the school. More importantly, a police officer in the school leads to better community engagement between the police department and the community. A police liaison officer properly chosen can enhance the cooperation between the police department and the school students and school staff.




Drug Enforcement Agency (DEA)

One investigator is detailed to the United States Drug Enforcement Agency (DEA). This unit is tasked with the investigation and interdiction of narcotics and money laundering related crimes throughout the United States. In 2012, the Unit generated \$101,191.91 in seizure funds to the police department which are used to support our law enforcement efforts.



Police K-9 Unit

The Elmhurst Police Department K-9 Program started in 1997. We are presently on our third K-9



since that time. **Officer Tony Pol**i and **K-9 Diesel**, who is a 4-year old Belgian Malinois imported from Hungary, currently staff the unit. Diesel is a multi-purpose dog trained to detect controlled substance odor, track individuals, search for and find evidence, conduct building/area searches, apprehend suspects, and protect the K-9 handler.

There were 101 situations requiring the services of the K-9 Unit in 2012. These situations included tracking, building/area searches and evidence searches resulting in 5 suspect apprehensions, 67 finds were drug-related (marijuana, cocaine, heroin) and \$2,847 in U.S. currency was seized.

Bicycle Unit

The Elmhurst Police Department Bicycle Unit provides police patrols to areas that are inaccessible to vehicular patrol. The use of this unit supports community interaction as it reduces patrol speeds, making officers more accessible to the public. The primary areas that are patrolled by the bicycle unit include parking lots, parks, wooded areas and special events.

Evidence Technicians

The Elmhurst Police Department Evidence Technician Unit consists of 11 specially trained officers, who—in addition to regular patrol duties—are responsible for recovering and processing crime scene evidence. The Evidence Techs use digital photography and latent print lifting equipment to trace evidence identification. 2012 Evidence Technician Officers: Suzanne Berry, Brendan Bruckner, Dan Corrigan, Matt McCollum, Rick Moulis, Jim O'Connor, John Pacewic, Doug Rumick, Guy Schweik, Tim Westering, Brad Wilcoxon and Evidence Custodian Bob Miklas. The Unit is supervised by Sergeants Jim Gandy and Mike Wiehe.

Our Evidence Technician officers completed 272 hours of training in 2012.

The Evidence Technician's duties include:

- Identifying, collecting, and preserving trace evidence
- Locating and preserving fingerprints
- Documenting crime scenes through still photography, video, diagrams and drawings
- Field testing suspected illegal drugs
- Testimony in criminal court

The Evidence Technician Unit was called upon many times in 2012 to process crime scenes and serious motor vehicle crashes in Elmhurst. Some of the crime scenes that were investigated in 2012 include:

- Arson and Weapon Offenses
- Serious Motor Vehicle Accidents
- Burglary (residential/business/motor vehicle)
- Crimes Against Person (assault and battery)
- ➤ Home Invasion
- Death Investigation
- Damage to City Property

Future plans for the Evidence Technician Program include additional training in crime scene mapping, sketching and diagramming. There are plans to conduct joint training with the DuPage County Crime Lab in 2013.



Administrative Services

Records Department



The Records Unit was staffed by **Supervisor Jodi Sennett** in the year 2012. The Police Records Division is responsible for performing a variety of detailed report preparation, record keeping, distribution and public contact duties, which must be performed within specified legal guidelines. The Records Division is entrusted with the administration and maintenance of all department records. All criminal histories, arrest records, police reports, traffic citations, statistical data and related

information are maintained within this division.

In addition to "*Providing the Best*" to the residents of Elmhurst, other law enforcement agencies, the courts and the general public, the Division's responsibilities include:

- Ensure compliance with State and Federal regulations governing public records law and records retention
- Prepare statistical reports
- Provide the City and State's Attorney's Office with the paperwork required for court

- Process subpoenas
- Register sex offenders and monitor sex offender registrations
- Assemble and furnish FOIA requests
- Process petitions, seals and orders of expungements
- Alarm billing
- Provide the press with our incident reports

Training



The coordination of training programs and opportunities for Department employees is the responsibility of *Sergeant Michael McLean*. The Elmhurst Police Department conducts a variety of training throughout the year. Training is presented through printed materials, videos, online, driving school, and department communications. Officers also attend offsite classes and seminars. Topics cover policy and procedures, criminal law, local ordinances and traffic laws. Additionally, many of our

officers hold specific certifications.

The majority of the training comes from North East Multi-Regional Training, Inc. (NEMRT) and Suburban Law Enforcement Academy (SLEA). The Intergovernmental Risk Management Agency (IRMA) provides training videos and nationally accredited driving courses. These courses focus on helping drivers to understand the safety and performance aspects of vehicle operation.

Specialty Units Training

Specialty Units (K-9, NIPAS, 5th District SWAT) participate in a minimum of 16 hours per month of *additional* training and a 40-hour block of skill set training twice per year. This level of training is consistent with the National Tactical Officers Association training guidelines.

Firearms Training


The Elmhurst PD currently has 4 State Certified Range Masters, 2 of which are Rifle Instructors. Other related fields the Range Masters are current in or formerly involved with include: Field Training Officers, Emergency Response Team Members, Master Firearms Instructors and Certified FBI Firearms Instructors. The Range Masters conduct Department-wide monthly training which maintains and further improves officers' firearms skills that may be required as part of their duties. In addition to training, the Range Masters are licensed armorer's and perform scheduled maintenance on Department owned firearms which results in large cost saving measures and promotes a high degree of readiness.

Internal Affairs



To maintain the highest level of public confidence, the Elmhurst Police Department investigates all complaints thoroughly and impartially. Internal Affairs investigations also address instances of employee behavior that could discredit the Department or violate a Department policy, procedure or practice. Complaints are presented to the Office of the Chief of Police for a fair review and appropriate action and/or sanction, with consideration given to the complainant, the

Department, the individual employee and the public trust.

In 2012, the Elmhurst Police Department investigated 7 formal complaints against its members.

Disposition of Complaint

Unfounded – Allegation is not factual; did not happen.

Exonerated – The act of the department or officer was consistent with the agency procedures.

Sustained – The allegation is supported by sufficient evidence.

DARE



The Elmhurst Police Department's Drug Abuse Resistance Education Program (DARE) began in 1987. The Elmhurst Police program challenges students to make good choices using the DARE Decision Making Model and covers topics such as alcohol and drug abuse, peer pressure, choosing good friends and self-confidence. In 2012, DARE America, the parent organization, updated the DARE program. The new program titled, "Keepin' it REAL", is based on preventing drug use by developing children's basic skills to make safe and responsible choices.

The Elmhurst Police Department has six officers who serve as our DARE instructors. They are Officers Brendan Bruckner, Tony Cuzzone, Josh Duffy, Matt McCollum,

Mike Reiman and Nick Waldenmeyer.

During the year, Elmhurst presented two Parent Information meetings and taught Internet Safety to the 6th grade class.

The academic school year culminates with a DARE graduation ceremony. In 2012, the Elmhurst community had approximately 900 students graduate. This is a special event that is attended by family, friends and community members. The DARE program is a valuable tool to connect with children in the community and provides them with the education necessary to keep them safe, make better decisions and help them to succeed.

As a reward for the students' hard work and commitment, they are taken on a field trip. In 2012, the students were treated to a Chicago White Sox game. The White Sox trip was specially organized for students and included a pre-game parade on the field for the students in attendance.

FLEET WATCH PROGRAM

This program utilizes public works and utility workers as an "extra set of eyes" in the community. The Police Department trains these workers to be alert for any suspicious activity. They are encouraged to take note of important information to assist officers in the event of a crime.

CITIZEN'S POLICE ACADEMY (CPA)

The Elmhurst Police Department is proud to present a Citizen's Police Academy. The 14-week program includes weekly presentations on topics ranging from Criminal and Civil Law and Police Tactics to Processing Crime Scenes. The Academy is an overwhelming success and concludes with a graduation ceremony.





The Citizen's Police Academy program is designed to provide our residents with a better understanding of police department functions as well as insight into law enforcement techniques. Classes are geared to assist citizens in understanding laws and police practices within our City. The program is open to anyone who works or resides in the City of Elmhurst. The curriculum includes information about the canine unit, criminal and civil law, crime prevention, juvenile law, evidence, traffic stops, 911

telecommunications, use of force, investigations, gangs and drugs, scams and confidence games, etc.

Attendees of the Citizen's Police Academy represent a variety of backgrounds. We believe that the entire community benefits when residents take a personal interest in the protection of their neighborhood. The academy also provides an opportunity for students to get to know the men and women who protect their community.



MUTUAL AID ASSIGNMENTS

The Elmhurst Police Department participates in the following mutual aid groups.

DuPage Major Crime Task Force (MCTF)



The DuPage Major Crime Task Force (MCTF) was first formed in late 1998 to promote County safety and enhance the ability of all law enforcement agencies in DuPage County to solve major crime through resource sharing, partnership and joint cooperation, consistent training, and application of investigative and enforcement methodology. The purpose of the MCTF is to provide member agencies with highly competent and comprehensive investigative, crime scene,

evidence collection, analysis, and technical assistance to incidents of major crimes.

Today, MCTF consists of 20 law enforcement agencies from federal, state, and local police agencies, and the DuPage County States Attorneys' Office. MCTF allows all of the member agencies to share equipment, personnel, and resources as needed for major investigations or significant events. The Elmhurst Police Department has members assigned to leadership roles in every aspect of the task force, including support, investigations, and forensics.

Illinois Law Enforcement Alarm System (ILEAS)

The Elmhurst Police Department is a member of the Illinois Law Enforcement Alarm System (ILEAS). This group is based in Urbana, Illinois, and is the largest mutual aid organization in the United States. ILEAS is responsible for coordinating statewide mutual aid responses as needed. Fortunately, during 2012, the Elmhurst Police did not request ILEAS assistance for any incident or receive any mutual aid requests.



THE ILEAS MISSION

We strive to meet the needs of law enforcement throughout the State of Illinois in matters of mutual aid, emergency response and the combining of resources for public safety.

"STRENGTH THROUGH COOPERATION"

Northern Illinois Police Alarm System (NIPAS)



The Northern Illinois Police Alarm System (NIPAS) consists of over 90 communities and offers two programs – a special tactical squad known as the Emergency Services Team and, a crowd control team known as the Mobile Field Force. Mobile Field Force had 1 activation in 2012, the NIPAS EST team

responded to 22 emergency calls that consisted of barricaded subjects, high risk search warrants and high risk arrest warrants. Officer Marcin Scislowicz serves on the NIPAS SWAT team and Officers Victor Almaguer and Art Ciszewski serve on the NIPAS Mobile Field Force.



Click It or Ticket & You Drink & Drive You Lose

In 2012, the traffic unit once again was awarded and took part in an Illinois Department of Transportation (IDOT) grant which focused on DUI and overnight seatbelt enforcement. This grant consisted of over \$45,000 of funding for this extra enforcement. These programs are highly visible, massive enforcement efforts designed to detect violators of Illinois traffic laws with special emphasis on alcohol and occupant protection. During 2012, the Elmhurst Police Department conducted 7 special enforcement details during the St. Patrick's Day, Memorial Day, Independence Day, Labor Day, Thanksgiving, Cinco De Mayo and Christmas holiday periods. During these special enforcement details, our officers issued a total of **1,276 traffic citations** and made **112 D.U.I. arrests**. This program is funded by an I.D.O.T. Traffic Safety Grant.



Other Highlights from 2012 Include:

- Train enforcement, including enforcement of both pedestrian and vehicle violations, on/near railroad crossings.
- The Elmhurst Police Department was recognized as being 6th in the State of Illinois for DUI arrests, with 367 DUI arrests the previous year.
- An increase of enforcement of cell phone usage in school and construction zones.
- During the last week of September, the traffic unit conducted several campaigns enforcing texting while driving violations throughout the City.

Alcohol & Tobacco Enforcement

The Elmhurst Police Department has 5 police officers that are state-certified to conduct enforcement stings. The stings are designed to educate retail establishments and eliminate the illegal sale of alcohol and tobacco to children in our community. The Alcohol and Tobacco Enforcement Officers for 2012 were:

Our department conducted 2 rounds of compliance checks throughout the year at businesses in the City of Elmhurst. All 2 rounds in 2012 resulted in 16 alcohol violations and 7 tobacco violations. The violators were cited for Unlawful Sale or Purchase of Alcohol and Prohibited Sales of Tobacco and were forwarded to the Liquor Commissioner for disposition. This program is funded by a grant from the State of Illinois.


Chronic Nuisance Program

Chronic Nuisance Ordinance - Currently the police department has 4 active Chronic Nuisance cases. 175 cases have been successfully resolved since 2008. Only 14 chronic nuisance cases re-offended with a second violation in 180 days and only 1 went to a third violation. This program continues to be successful in improving quality of life issues for residents and businesses. The chart below shows the success of the program – there has been a decrease in Chronic Nuisance cases every year since its inception.

The Police Department continues to work with the Building Department to enforce quality of life concerns such as:

- After hours construction.
- Excessive mud/debris left on street due to construction traffic.
- Construction vehicle parking.

Chronic Nuisance Totals by Year





In 2012, the total service workload decreased by 2% over the previous year. The total calls for service increased 3% over the previous year.


Motor Vehicle Crashes





Award of Valor



Officer Rick Moulis was presented the Award of Valor. On October 15, 2012, officers were dispatched to a residence for a domestic battery. Officer Rick Moulis was the first to arrive and heard a man and woman arguing loudly. He entered the residence alone to ensure the safety of the combatants. Upon entering a small bedroom, he found one man and three women. The man raised a knife over his head and began to move towards the women who appeared to be afraid of him. Officer Moulis acted

quickly and deployed his Taser, stopping

the man from further advancing towards them. He struck the offender in his side causing him to fall to the ground and was then able to take him into custody.

Officer Moulis is recognized for his bravery as he entered the home alone, confronted an armed offender and addressed the threat. It is possible that if he had not entered the home and intervened in the confrontation, someone may have been seriously harmed.

On June 10, 2012, Officer Laural Panico and Service Officer Julie Dickinson responded to a residence for a subject in full arrest. They found a 72 year old victim inside a vehicle with her daughter giving her CPR while family members were standing near the car, adding to the stress of the situation.

Officer Panico and SO Dickinson set up the AED and administered a shock to the victim; CPR was continued until Elmhurst paramedics arrived. They

took control of the victim and started advanced life support, gaining a pulse.

The actions of Officer Panico and Service Officer Dickinson are recognized as their quick response and team work saved a woman's life in a very stressful situation.


