Zoning Regulation Amendment

Section 12.4.12

Veterinary hospitals to include pet services such as overnight boarding, day care grooming and training provided that the applicant shall demonstrate all reasonable efforts to prevent any unreasonable offensive odor or excessively loud noise and to establish an effective protocol for waste removal.
