





20 YEAR A RESOLUTION APPROPRIATING \$6,250,000 FOR COSTS ASSOCIATED WITH THE INSPECTION AND CONSTRUCTION PHASE OF THE EAST TRUNK WETLANDS CROSSING PROJECT, AUTHORIZING A GRANT TO REIMBURSE \$750,000 OF SUCH APPROPRIATION AND AUTHORIZING THE ISSUANCE OF BONDS IN AN AMOUNT NOT TO EXCEED \$2,000,000 TO FINANCE A PORTION OF SUCH APPROPRIATION.

WHEREAS, the Town of Fairfield, Connecticut (the "Town") seeks to appropriate \$6,250,000 for the costs associated with the inspection and construction phases of the East Trunk Wetlands Crossing Project (the "Appropriation"); and

WHEREAS, the Appropriation shall be funded by several sources including: 1) \$3,500,000 from the Town's Water Pollution Control Authority (the "WPCA") fund balance; 2) \$750,000 in grant funds from the State of Connecticut's Urban Act Grant Program (the "Grant"); and 3) \$2,000,000 in bonds issued by the Town (the "Bonds"); and

WHEREAS, the Town seeks to authorize the Appropriation, to negotiate and accept the terms of the Grant and the Bonds in an amount not to exceed \$2,000,000; and

WHEREAS, while the Town is liable for the debt service on the Bonds, for internal accounting purposes, it is appropriate that all costs of the Project including debt service on the Bonds be allocated to, and reimbursed to the Town by, the WPCA; and

WHEREAS, simultaneously herewith, the Town shall secure approval of a Supplemental Resolution providing that all debt service on the Bonds shall be paid by the WPCA from its own funds as such debt service becomes due and the obligation of the WPCA shall be set forth in a memorandum of understanding with the Town satisfactory to the First Selectwoman; and

NOW, THEREFORE, IT IS HEREBY:

RESOLVED:

- 1. As recommended by the Board of Finance and the Board of Selectmen, the Town of Fairfield (the "Town") hereby appropriates the sum of Six Million Two Hundred Fifty Thousand and 00/100 Dollars (\$6,250,000) for costs of the inspection and construction phase of the East Trunk Wetlands crossing project, including but not limited to, the costs to replace the existing sanitary sewer pipe with a new pipe along the same alignment within an embankment across the Ash Creek Inlet wetlands adjacent to the Metro Center, and all related design, environmental inspection, administrative, financing, legal, contingency and other soft costs (the "Project").
- 2. The First Selectwoman is hereby authorized and directed to negotiate and accept the terms of a state grant under the Urban Act Grant Program in the amount of Seven Hundred Fifty

Thousand and 00/100 (\$750,000) Dollars to fund a portion of the Project (the "Grant"). The First Selectwoman is also hereby authorized to enter into, on behalf of the Town, a Grant agreement or other document memorializing the terms of the Grant and to take all action necessary or reasonably required to carry out, give effect and consummate such Grant including executing on behalf of the Town such documents, agreements, contracts and certificates as deemed to be necessary or advisable by the First Selectwoman.

- 3. As recommended by the Board of Finance and the Board of Selectmen, the Town may borrow a sum not to exceed Two Million and 00/100 Dollars (\$2,000,000) and issue its general obligation bonds/bond anticipation notes for such indebtedness under its corporate name and seal and upon the full faith and credit of the Town in an amount not to exceed said sum for the purpose of financing the appropriation for the Project.
- 4. The Board of Selectmen, the Treasurer and the Chief Fiscal Officer of the Town are hereby appointed a committee (the "Committee") with full power and authority to cause said bonds to be sold, issued and delivered; to determine their form and terms, including provision for redemption prior to maturity; to determine the aggregate principal amount thereof within the amount hereby authorized and the denominations and maturities thereof; to fix the time of issue of each series thereof and the rate or rates of interest thereon as herein provided; to determine whether the interest rate on any series will be fixed or variable and to determine the method by which the variable rate will be determined, the terms of conversion, if any, from one mode to another or from fixed to variable; to set whatever other terms of the bonds they deem necessary, desirable or appropriate; to designate the bank or trust company to certify the issuance thereof and to act as transfer agent, paying agent and as registrar for the bonds, and to designate bond counsel. The Committee shall have all appropriate powers under the Connecticut General Statutes, as amended (the "Statutes") including Chapter 748 (Registered Public Obligations Act) and Chapter 109 (Municipal Bond Issues) to issue, sell and deliver the bonds and, further, shall have full power and authority to do all that is required under the Internal Revenue Code of 1986, as amended, and under rules of the Securities and Exchange Commission, and other applicable laws and regulations of the United States, to provide for issuance of the bonds in tax exempt form and to meet all requirements which are or may become necessary in and subsequent to the issuance and delivery of the bonds in order that the interest on the bonds be and remain exempt from Federal income taxes, including, without limitation, to covenant and agree to restriction on investment yield of bond proceeds, rebate of arbitrage earnings, expenditure of proceeds within required time limitations, the filing of information reports as and when required, and the execution of Continuing Disclosure Agreements for the benefit of the holders of the bonds and notes.
- 5. The First Selectwoman and Treasurer or Chief Fiscal Officer, on behalf of the Town, shall execute and deliver such bond purchase agreements, reimbursement agreements, line of credit agreement, credit facilities, remarketing, standby marketing agreements, standby bond purchase agreements, and any other commercially necessary or appropriate agreements which the Committee determines are necessary, appropriate or desirable in connection with or incidental to the sale and issuance of bonds, and if the Committee

determines that it is necessary, appropriate, or desirable, the obligations under such agreements shall be secured by the Town's full faith and credit.

- 6. The First Selectwoman and Treasurer or Chief Fiscal Officer shall execute on the Town's behalf such interest rate swap agreements or similar agreements related to the bonds for the purpose of managing interest rate risk which the Committee determines are necessary, appropriate or desirable in connection with or incidental to the carrying or selling and issuance of the bonds, and if the Committee determines that it is necessary, appropriate or desirable, the obligations under such interest rate swap agreements shall be secured by the Town's full faith and credit.
- 7. The bonds may be designated "Public Improvement Bonds of the Town of Fairfield", series of the year of their issuance and may be issued in one or more series, and may be consolidated as part of the same issue with other bonds of the Town; shall be in serial form maturing in not more than twenty (20) annual installments of principal, the first installment to mature not later than three years from the date of issue and the last installment to mature not later than twenty (20) years from the date of issuance or as otherwise provided by statute. The bonds may be sold at an aggregate sales price of not less than par and accrued interest at public sale upon invitation for bids to the responsible bidder submitting the bid resulting in the lowest true interest cost to the Town, provided that nothing herein shall prevent the Town from rejecting all bids submitted in response to any one invitation for bids and the right to so reject all bids is hereby reserved, and further provided that the Committee may sell the bonds on a negotiated basis, as provided by statute. Interest on the bonds shall be payable semi-annually or annually. The bonds shall be signed on behalf of the Town by at least a majority of the Board of Selectmen and the Treasurer, and shall bear the seal of the Town. The signing, sealing and certification of the bonds may be by facsimile as provided by statute.
- 8. The Committee is further authorized to make temporary borrowings as authorized by the Statutes and to issue temporary notes of the Town in anticipation of the receipt of proceeds from the sale of the bonds to be issued pursuant to this resolution. Such notes shall be issued and renewed at such time and with such maturities, requirements and limitations as provided by the Statutes. Notes evidencing such borrowings shall be signed by the First Selectwoman and Treasurer or Chief Fiscal Officer, have the seal of the Town affixed, which signing and sealing may be by facsimile as provided by statute, be certified by and payable at a bank or trust company incorporated under the laws of this or any other state, or of the United States, be approved as to their legality by bond counsel and may be consolidated with the issuance of other Town bond anticipation notes. The Committee shall determine the date, maturity, interest rates, form and manner of sale, including negotiated sale, and other details of said notes consistent with the provisions of this resolution and the Statutes and shall have all powers and authority as set forth above in connection with the issuance of bonds and especially with respect to compliance with the requirements of the Internal Revenue Code of 1986, as amended, and regulations thereunder in order to obtain and maintain issuance of the notes in tax exempt form.

- 9. Pursuant to Section 1.150-2, as amended, of the Federal Income Tax Regulations the Town hereby declares its official intent to reimburse expenditures (if any) paid for the Project from its General or Capital Funds, such reimbursement to be made from the proceeds of the sale of bonds and notes authorized herein and in accordance with the time limitations and other requirements of said regulations.
- 10. The First Selectwoman, Chief Fiscal Officer and Town Treasurer are hereby authorized, on behalf of the Town, to enter into agreements or otherwise covenant for the benefit of bondholders to provide information on an annual or other periodic basis to the Municipal Securities Rulemaking Board (the "MSRB") and to provide notices to the MSRB of material events as enumerated in Securities and Exchange Commission Exchange Act Rule 15c2-12, as amended, as may be necessary, appropriate or desirable to effect the sale of the bonds and notes authorized by this resolution.
- 11. The Committee is hereby authorized to take all action necessary and proper for the sale, issuance and delivery of the bonds and notes in accordance with the provisions of the Statutes and the laws of the United States.
- 12. The First Selectwoman or other proper Town official is authorized to apply for and accept any available State or Federal grant, in addition to the Grant as defined in paragraph 2 herein, in aid of the financing of the Project, and to take all action necessary and proper in connection therewith. Any such grants or contribution received prior to the issuance of the Bonds authorized herein shall be applied to the costs of the Project or to pay at maturity the principal of any outstanding bond anticipation notes issued pursuant this resolution and shall reduce the amount of the Bonds that can be issued pursuant to this resolution. If such grants and contributions are received after the issuance of the Bonds, they shall be applied to pay the principal on the Bonds or as otherwise authorized by the Board of Selectmen, Board of Finance and Representative Town Meeting provided such application does not adversely affect the tax-exempt status of the Bonds or the Town's receipt of such grant or contribution.

SUPPLEMENTAL RESOLUTION

WHEREAS, the Town of Fairfield (the "Town") has adopted at the request of the Water Pollution Control Authority ("WPCA") a Resolution entitled "A RESOLUTION APPROPRIATING \$6,250,000 FOR COSTS ASSOCIATED WITH THE INSPECTION AND CONSTRUCTION PHASE OF THE EAST TRUNK WETLANDS CROSSING PROJECT, AUTHORIZING A GRANT TO REIMBURSE \$750,000 OF SUCH APPROPRIATION AND AUTHORIZING THE ISSUANCE OF BONDS IN AN AMOUNT NOT TO EXCEED \$2,000,000 TO FINANCE A PORTION OF SUCH APPROPRIATION" (the "Resolution"); and

WHEREAS, the Resolution appropriates \$6,250,000 (the "Appropriation") for costs associated with the inspection and construction phases of the East Trunk Wetlands Crossing Project (the "Project"); and

WHEREAS, the Appropriation shall be funded by several sources including: 1) \$3,500,000 from the WPCA fund balance; 2) \$750,000 in grant funds from the State of Connecticut's Urban Act Grant Program (the "Grant"); and 3) \$2,000,000 in bonds issued by the Town (the "Bonds"); and

WHEREAS, the Resolution authorizes the Appropriation, the negotiation and acceptance of the terms of the Grant and authorizes the Bonds in an amount not to exceed \$2,000,000; and

WHEREAS, while the Town is liable for the debt service on the Bonds, for internal accounting purposes, it is appropriate that all costs of the Project including debt service on the Bonds be allocated to, and reimbursed to the Town by, the WPCA; and

WHEREAS, the WPCA has agreed to pay for the costs of the Project and the debt service on the Bonds authorized by the Resolution; and

NOW, THEREFORE, IT IS HEREBY:

RESOLVED,

- That the debt service on the Bonds as such debt service becomes due shall be paid by the WPCA from its own funds and the obligation of the WPCA shall be set forth in a memorandum of understanding (the "MOU") with the Town satisfactory to the First Selectwoman; and
- 2) That the First Selectwoman is hereby authorized to execute the MOU on behalf of the Town.

East Trunk Sewer Metro Wetlands Crossing – Construction/Inspection Phase

Project cost - \$ 6,250,000 (includes Contingency)

Town Share – \$ 5,500,000 broken down as \$3.5 million to come from WPCA Fund Balance and \$2 million to be bonded.

Grant-\$ 750,000 Urban Act grant extended and transferred from East Trunk sewer project.

- <u>BACKGROUND</u> East Trunk Sewer Wetlands Crossing project will replace approximately 311 linear feet of existing 33" sanitary sewer pipe with a new 36" pipe along the same alignment within an embankment across the Ash Creek Inlet wetlands adjacent to the Metro Center. This project will reduce Inflow & Infiltration (I&I), reduce Sewer System Overflows (SSO), and increase capacity for future development. Design services for this project were awarded to D&B Engineers in April 2021. Construction Plans are completed. Permits have been obtained to start construction.
- <u>PURPOSE</u> To replace sewer main that carries about 2/3 of Town sewer flows to the WPCF plant. The new 36 inch line will expand capacity for Metro Center development and provide necessary improvements to the system.
- <u>DESCRIPTION OF PROPOSAL</u> -The request includes Construction of the sewer, design services during construction, specialized inspections, environmental inspection, and general daily inspections.
- <u>RELIABILITY OF COST ESTIMATE</u> This estimate is based on the latest information of the design consultant for construction and inspection costs are based on number of days for anticipated construction. (13-16 months) Using 16 month as worst case scenario.
- 5. <u>INCREASED EFFICENCY AND PRODUCTIVITY</u> same as number 2.
- <u>ADDITIONAL LONG RANGE COST</u> Cost to complete the pipe replacement will depend on actual contract bids and final field conditions.
- 7. <u>ADDITIONAL USE OR DEMAND ON EXISTING FACILITES</u> increased capacity in sewer line. New line should have significantly less maintenance than current line.
- 8. <u>ALTERNATES TO THIS REQUEST</u> None, Town might be liable for additional Sanitary Sewer Overflows and future development could be severely limited.
- 9. <u>SAFETY AND LOSS CONTROL</u> Environmental conditions will improve with project.
- 10. <u>ENVIRONMENTAL CONSIDERATIONS</u>—are listed in construction bid documents (plans and specifications). Town must hire Licensed Environmental Professional and perform specialized inspections throughout the project per (IBC) building codes.
- 11. <u>INSURANCE</u> Consultant will be required to carry the necessary insurance as directed by the Town of Fairfield Purchasing Department.
- 12. <u>FINANCING</u> As detailed earlier, Project costs are broken down into different sections. The Town Share is anticipated to be \$ 5,500,000, broken down as \$3.5 Million to come from WPCA Fund Balance, \$ 2 Million to be Bonded by Capital Improvements and Town will be utilizing a \$ 750,000 grant that was extended and transferred from another East Trunk sewer project. Project has been listed on Capital Waterfall (5 year planning document) for some time now.

- 1. The estimating software that was utilized was Sage Estimating Version 20.1 for detailed back-up estimate and Excel for estimate summaries. Additionally R.S. Mean's data bases and historical databases were utilized for material pricing and labor/equipment productivity rates.
- 2. Pricing in the estimate is based on crew pricing in which individual line items are assigned a crew and a production rate for that crew. Each crew is comprised of individual resources (labor & equipment).
- 3. Labor rates are based on Prevailing Wage Rates as published by Connecticut Department of Labor for the period beginning July 2022. These labor rates (base rates and supplemental rates) including payroll taxes and insurance were loaded into the Sage Estimating database rate tables for use in this estimate. Equipment rates are based on R.S. Means 2022 equipment rate tables.
- 4. The estimate was developed in general accordance with guidelines established by the Association for the Advancement of Cost Estimating International (AACEI) and is most accurately described as a Class 4 cost estimate. A detailed description of the estimate class is provided below.

AACE International CLASS 4 Cost Estimate – Class 4 estimates are generally prepared based on limited information and subsequently have fairly wide accuracy ranges. Typically, engineering is 1% to 15% complete. They are typically used for project screening, determination of feasibility, concept evaluation, and preliminary budget approval. Virtually all Class 4 estimates use stochastic estimating methods such as cost curves, capacity factors, and other parametric and modeling techniques. Expected accuracy ranges are from –15% to –30% on the low side and +20% to 50% on the high side, depending on the technological complexity of the project, appropriate reference information, and the inclusion of an appropriate contingency determination. Ranges could exceed those shown in unusual circumstances. As little as 20 hours or less to perhaps more than 300 hours may be spent preparing the estimate depending on the project and estimating methodology (AACE International Recommended Practices and Standards).

- 5. The estimate is based on a single prime lump sum contract. Notice to proceed is anticipated to be December of 2022 with 16 month duration to substantial completion.
- 6. The estimate is based on crews working 8 hours day, 5 days per week. There is no planned use of overtime included in this estimate, although an allowance of 5% allocated to labor costs has been included for "incidental overtime".
- 7. Labor productivity is based on R.S. Means and historical in house production rates. Constraints due to construction sequencing and site conditions have been included in the individual line item's productivity rates
- 8. Escalation is calculated from October 2022 to a mid-point of construction of August 2023 at 5% per annum compounded.
- 9. Due to recent increases/fluctuations in construction materials a 10% contingency factor has been added to estimate

D&B Engineers and Architects (D&B) is pleased to submit this Letter Proposal for Professional Engineering Services required to provide Design Services During Construction (DSDC), Construction Management (CM) and Inspection Services for the Town of Fairfield East Trunk Sewer Wetland Crossing.

The subject property is located in the vicinity of the Fairfield Metro Center Site which is located at 219 Ash Boulevard in Fairfield, Connecticut. During the period from 1940 to 1986 the site was owned and operated by either the Bullard Company or Best Cast and experienced significant contamination from utilization as a sand-casting foundry. Numerous soil and groundwater investigations and associated remediation activities have occurred on site as greater than 50% of the site was covered by casting sands.

Project Background:

D&B understands that the primary construction items include work associated with the excavation, demolition and removal of the existing 33-inch reinforced concrete gravity sewer, the installation and connection of a new 36-inch reinforced concrete gravity sewer pipe and the construction of a new precast reinforced manhole. The selected contractor will be required to complete their work within sixteen (16) months from the Notice to Proceed. The Town is now seeking a professional engineering consultant to provide design services during construction, construction administration, management and fulltime inspection services related to this work. D&B's proposal is based on our previous design experience on the project, review of the information provided by the Town, and internal technical discussions regarding projects with similar conditions.

Scope of Work:

Design Services during Construction (DSDC)

D&B proposed to perform the following tasks associated with Design Services during Construction (DSDC)

- 1. D&B and their subconsultants will verify and approve samples, schedules, shop drawings and other submissions for conformance with information given in the Contract Documents. In addition, D&B will prepare responses to address Requests for Information from the Contractor.
- 2. D&B and their subconsultants will consult with the Town of Fairfield prior to the preparation of any change order documents requested by the Contractor. D&B will prepare the change order(s) accordingly and submit them to the Town of Fairfield for their review and approval.
- 3. D&B and their subconsultants will be available for conference calls, meetings and make site visits as requested. It is assumed that D&B would perform six (6) site visits throughout the project duration.

Construction Management Services (CM)

- 1. D&B and their subconsultants will provide construction management and inspection services related to the Town of Fairfield East Trunk Sewer Wetland Crossing Project and will include but not be limited to the following items:
 - a. Identify scheduled work assignments, contractors on-site and overall site conditions
 - b. Record contractor hours on the job site, number of contractor's work force, name of foreman and list of equipment used.
 - c. Record site conditions i.e., weather conditions/factors
 - d. Monitor change order work
 - e. Record list of visitors to the job site
 - f. Detail daily activities.
 - g. Identify field decisions
 - h. Provide general observations
 - i. Refer to specification as needed to provide the necessary descriptive details, for items such as test procedures.
 - j. Record work not performed as specified

- k. Prepare daily written inspection reports including photographic record
- 1. Maintain progress payment documents
- D&B's proposed inspection cost is based on one full time inspector at a loaded rate of \$150/hr for a projected construction duration ranging from thirteen (13) to sixteen (16) months. D&B will also provide office support services to assist the field engineer on an as needed basis.

Construction Management Associated with Special Inspections and Support of Excavation

- 1. D&B's subconsultant Meuser Rutledge Consulting Engineers PLLC (MRCE) will perform construction management services associated with the support of excavation which will include the inspection of drilled soldier / foundation piles, SOE installation, soil subgrades and include the preparation of Daily Field Reports. Additionally, MRCE will provide office support to the Field Engineer and respond to any associated field questions.
- 2. This work will be billed at a rate of \$1,150 per day for field inspector services for a 9-hour day including travel time and travel expenses and the preparation of a Daily Field Report. Office support is to be billed at a rate of a half hour per day for \$150/day. The current estimated schedule related to the SOE is estimated to be approximately 80 days. Additional days will be charged at the specified rate. In order to minimize the risk associated with additional inspection, contractor liquidated damages could be included for exceedance of the time contractually allotted for completion of the SOE.



A WPCA Regular meeting was held via Webex at 7:00 p.m. on Wednesday, December 15, 2021.

Present: Vice Chair Joseph D'Avanzo, Ron Drew, Chairman Mark Elletson, Matt Manchisi, Chris Steiner

Absent: Tom McCarthy, Nancy Lefkowitz

Also Present: Christian Dockum, WPCA Superintendent John Bodie, Chris Cardany, John Clancy WPCA Administrator/Inspector, Fairfield University VP Facilities David Frasinelli, Steve Gniadek of 974 Fairfield Beach Road, Julie McGoldrick of 171 Acorn Lane, Gregory Sargent of 1450 Fairfield Beach Road.

1. Call to Order – Chairman Elletson called the meeting to order at 7:01 p.m. and welcomed Chris Steiner.

Joseph D'Avanzo motioned to add an item to the Agenda under 4. Old Business "b) To Act Upon a Request for Additional Funding for Micro Grid Project". Ron Drew seconded the motion which carried unanimously.

2. Bills and Communications - Approval of November 17, 2021, Regular Meeting Minutes

Joseph D'Avanzo motioned to approve the November 17, 2021, Regular Meeting Minutes. Matt Manchisi seconded the motion which carried unanimously.

3. New Business

1. Consider and act on election of officers for 2022 WPCA Commission

Joseph D'Avanzo motioned to elect Mark Elletson as Chair. Ron Drew seconded the motion which carried unanimously.

Ron Drew motioned to elect Joseph D'Avanzo as Vice Chair. Matt Manchisi seconded the motion which carried unanimously.

2. Approval of meeting dates for 2022

Joseph D'Avanzo motioned to approve the 2022 meeting dates as presented; meeting the third Wednesday of the month at 7:00 p.m. Chris Steiner seconded the motion which carried unanimously.

3. Consider and act on a request from Fairfield University to connect two multi-story townhouse residences with a total of 84 beds to the Fairfield Sewer system

Mr. Frasinelli gave a brief overview, then opened up to the Commission for questions and comments. He said they received P&Z approval to build two buildings in the north end of campus for student housing with a total of 84 beds. Flow testing capacity in two locations is complete and calculations prepared by Langan Engineering was submitted to WPCA. Mr. Bodie reviewed the report and doesn't see any issue with the added flow. Mr. Frasinelli described locations and confirmed they tested during a rain event.

Joseph D'Avanzo motioned to approve Fairfield University's request to connect two town house residences, buildings 16 and 17, with a total of 84 bedrooms. This approval will be effective for two years. The applicant will have to return to the Commission for approval in January 2024 if construction has not begun. The approval is subject to payment of \$136,765 which is calculated as the sewer usage fee. The fee is be to paid when the permit is issued. Matt Manchisi seconded the motion which carried unanimously.

4. Consider and act on additional funding for borings for East Trunk Wetlands Crossing Project

Mr. Elletson said he met with the Staff, Engineering and the contractor and shared the documentation (included in backup) with the Commission. He summarized the RFP process relative to the pipe replacement (36" to 30") on lining the Metro Center project. He said they could use the in-house test data. In some locations they need to bring in a large crane to drill down to determine the boring capacity. There is soil work associated with that work and need additional funding to perform the work.

Joseph D'Avanzo motioned to provide up to \$31,000 funding for borings for the East Trunk Wetlands Crossing Project. Matt Manchisi seconded the motion which carried. (Steiner abstained).

a) Sewer Adjustments: Mr. Elletson noted they are in the process of revising the policy so residents don't have to present to WPCA and the adjustments can be handled by the department. Mr. D'Avanzo summarized the below situations.

1. 222 High Ridge Road - Raul Herrera

Joseph D'Avanzo recommended they adjust the bill to \$150 which is the minimum usage fee and the credit the account \$1,494.96 that was already paid less the \$150. Chris Steiner seconded the motion which carried unanimously.

2. 171 Acorn Lane - Julie McGoldrick

Joseph D'Avanzo motioned to recalculate the bill eliminating March and use the months December, January, February and multiply by three giving an adjusted bill of \$510.60. A portion of the bill was previously paid and she will pay the difference. Ron Drew seconded the motion which carried unanimously.

3. 974 Fairfield Beach Road - Steven Gniadek

Mr. D'Avanzo stated the Commission is not prepared to approve without further review of the calculations.

No action taken.

4. 1174 Bronson Road – Steven Pfann

Joseph D'Avanzo motioned to postpone the item. The motion was seconded and carried unanimously.

Mr. D'Avanzo will review the history and will propose they give him credit for what was paid on the last three years' bills and then take the last three years' bills and charge the minimum rate of \$150. The premise is a nursery.

4. Old Business

a) 1450 Fairfield Beach Road – Gregory Oliver Sargent

Joseph D'Avanzo motioned to adjust the last three years' charges (2019, 2020, 2021) totaling \$2,546.84 crediting the last three years back to Mr. Sargent and recommended a zero bill. The land is a farm, with no connection to Sewer system. Matt Manchisi seconded the motion which carried. (Elletson abstained).

b) To Act Upon a Request for Additional Funding for Micro Grid Project

Mr. Bodie explained the Yankee Electric May Change Order. WPCA approved \$144,388.43 in May. It is short \$91,166.57 which is for the additional work at the Fire Training Center, Conservation and Animal Control sites. Yankee Electric can't proceed without the additional funds. Mr. D'Avanzo said the Town and Commission had a 50/50 split agreement. Mr. Bodie said they received a bill for additional work for contaminated soil. Mr. Bodie will meet with Ms. Pulie for further clarification. Mr. Bodie said we can wait to take action until January.

No action taken.

5. Update on Current Projects - Status of projects were reviewed (document can be found in Back Up). Mr. Clancy walked through the projects in priority order.

6. Status Update on Sewer Bypasses - Mr. Clancy provided an update,

Christian Dockum's term has expired. Christian indicated he is willing to continue to help the WPCA Commission and appreciates their work. The Commission thanked Mr. Dockum for all his contributions.

7. Adjournment

Ron Drew motioned to adjourn the meeting adjourned at 8:16 p.m. Matt Manchisi seconded the motion which carried unanimously.

A WPCA Regular meeting was held via Webex and In Person at 7:00 p.m. on Wednesday, October 19, 2022.

Present: Vice Chairman Joseph D'Avanzo, Ron Drew (via Webex), Chairman Mark Elletson (via Webex), Matt Manchisi, Tom McCarthy, Chris Steiner

Absent: Nancy Lefkowitz

Also Present: John Bodie WPCA Superintendent, John Clancy WPCA Administrator/ Inspector, Bill Hurly Engineering (arrived 7:35 p.m.), Megha Jain Engineering

1. Call to Order – Chairman Elletson called the meeting to order at 7:00 p.m.

2. Bills and Communications

a. Approval of the September 21, 2022, Regular Meeting Minutes

Chris Steiner motioned to approve the September 21, 2022, Regular meeting minutes. Tom McCarthy seconded the motion which carried, 5-0-1. (D'Avanzo, Elletson, Manchisi, McCarthy, Steiner in favor and Drew abstained)

3. New Business

- a) Sewer Adjustments
 - i. 931 Fairfield Beach Road

Joseph D'Avanzo motioned to authorize the Fairfield Tax Collector to adjust the 2021 sewer usage bill for 931 Fairfield Beach Road to \$509.57 which represents the average bill of the average client of the sewer system. Chris Steiner seconded the motion which carried unanimously, 6-0. (D'Avanzo, Drew, Elletson, Manchisi, McCarthy, Steiner in favor)

ii. 480 Hulls Highway

Joseph D'Avanzo motioned to authorize the Fairfield Tax Collector to adjust the 2021 sewer usage bill for 480 Hulls Highway to the average of the prior two years' which calculates to be \$846.20. Chris Steiner seconded the motion which carried unanimously, 6-0. (D'Avanzo, Drew, Elletson, Manchisi, McCarthy, Steiner in favor)

iii. 3915 Park Avenue Unit 58

Joseph D'Avanzo motioned to authorize the Fairfield Tax Collector to adjust the 2021 sewer usage bill for 3915 Park Avenue Unit 58 to equal the prior years' sewer

bill of \$1,115.04. Chris Steiner seconded the motion which carried unanimously, 6-0. (D'Avanzo, Drew, Elletson, Manchisi, McCarthy, Steiner in favor)

iv. 268 Berkley Road

Joseph D'Avanzo motioned to authorize the Fairfield Tax Collector to adjust the 2021 sewer usage bill for 268 Berkley Road to \$707.11 which is calculated to be the prior years' water usage times the current rate. Matt Manchisi seconded the motion which carried unanimously, 6-0. (D'Avanzo, Drew, Elletson, Manchisi, McCarthy, Steiner in favor)

b) To hear, consider and act on a request for funding environmental specs and design services for Tighe & Bond for the East Trunk sewer totaling \$7,500.

Chris Steiner motioned to approve up to \$7,500 for design services for Tighe & Bond. Tom McCarthy seconded the motion.

Ms. Jain explained there are two phases of the east trunk line. Tighe & Bond is Phase 2 and the cost for environmental boring services is \$7,500. Mr. Bodie supplied the cost breakdown. Ms. Jain said the investigation is to determine if there is suitable soil to make it constructible. Tighe & Bond will provide this data to Cardinal Engineering, which is designing the foundation. Ms. Jain said they will consider trenchless, if feasible. She said geotechnical information will be evaluated and will look into the specifications further. Further discussion on cost savings using one contractor vs. two, the geotechnical investigation, and deep borings and methods ensued.

Joseph D'Avanzo motioned to move Item (e) ahead of Items (b) & (d). Matt Manchisi seconded the motion which carried unanimously, 6-0. (D'Avanzo, Drew, Elletson, Manchisi, McCarthy, Steiner in favor).

Discussion of Item (b) continued after voting on Item (e). Mr. Hurley gave his recollection of the project. He said the Town applied for a Connecticut Communities Grant. In the past the grant has been between \$1m and \$2m but now could be up to \$10m. The decision about grant availability should be made in approximately a month. Grants are dependent upon either "a quick build or shovel ready" so they could want us to start right away. Tighe & Bond is preparing the report, but not doing borings.

The motion carried unanimously, 6-0. (D'Avanzo, Drew, Elletson, Manchisi, McCarthy, Steiner in favor)

c) To hear, consider and act on a request for funding change order from D&B Engineers for the Metro-Wetlands Crossing totaling \$35,000.

Mr. Hurley said the project fee increased and the Commission approved a \$31,000 change order last December but it never went further. There was confusion on the funding which was cleared up and he must get on the other Town boards' agendas.

No action taken.

d) To hear, consider and act on a request for funding for Cardinal Engineering for Plan updating, utility coordination and revised bid documents for East Trunk Sewer totaling \$30,000. This could increase to an estimated \$50K, if laterals to connect houses on Kenwood Rd. need to be included in revised design.

Mr. Hurley gave the current status of the grant which has been submitted. He anticipates the award in 4-6 weeks. The State uses a designer and a different inspector. The item has to go to the other Town Boards. Mr. Bodie is concerned that the laterals are not included. Mr. Steiner thinks we should leave as designed. Mr. Elletson said the whole spec package hooking up the homeowners was not included in the original design. Mr. Hurley said they will work together to get better data and suggested to wait a month to get more information.

Chris Steiner motioned to act on a request for Cardinal Engineering for Plan updating, utility coordination and revised bid documents for East Trunk Sewer up to \$30,000. The motion failed with no second.

Mr. D'Avanzo and Mr. Manchisi suggested requesting homeowner's approval before any costs are included. Mr. D'Avanzo and Mr. Manchisi also indicated the homeowners can remain as currently connected, as it would be a significant expense to connect these homes. Mr. Drew feels it is premature to speak to the homeowners and said we could do our end and they can connect when they want.

Chris Steiner motioned to act on request for Cardinal Engineering for Plan updating, utility coordination and revised bid documents for East Trunk Sewer up to \$30,000. Joseph D'Avanzo seconded the motion.

Discussion.

Joseph D'Avanzo amended the motion to approve funding for Cardinal Engineering for Plan updating, utility coordination, deep borings and revised bid documents for East Trunk Sewer up to \$44,000. Matt Manchisi seconded the motion which carried unanimously, 6-0.

e) To hear, consider and act on funding for a 250KW trailer mounted generator totaling \$125,000.

Mr. Bodie explained the generator at the Easton pump station failed in May and is under warranty but a rental unit is not included. Mike Ruddy agreed to cover the rental. As generators occasionally fail at various sites, it is beneficial both from a cost and logistics standpoint to have the flexibility with our own unit. Mr. D'Avanzo suggested management should replace/rotate this portable unit every two to three years, moving the portable "two/three" year old unit to replace an older permanent unit.

The generator has a 30-40 year life, runs on diesel, is fully insured, will cover all eight pump stations and part of plant that is not under generator power and Town Hall or other town locations, if necessary. The unit will reduce an operating budget line for rental. (the weekly rental cost is \$2,100).

Chris Steiner motioned act on funding for a 250KW trailer mounted generator up to \$125,000. Tom McCarthy seconded the motion which carried unanimously, 6-0. (D'Avanzo, Drew, Elletson, Manchisi, McCarthy, Steiner in favor)

Item (b) was discussed next.

f) Preliminary: To hear, consider and act on a request for funding for Construction Administration, Daily and specialized Inspection and (re) Design Services during Construction for Metro East Trunk Wetland Crossing. This would involve 3 firms. Estimate \$500,000.

Mr. Hurley reported it is close to being finalized and has been put out to bid. It would include construction administration, inspection and redesign services. Mr. Hurley will follow up to get the number locked down.

Joseph D'Avanzo motioned to put on table for discussion. Matt Manchisi seconded the motion.

Mr. Hurley said construction costs are estimated to be \$5.5m. It is on the FY 24-25 waterfall to be bonded. He said there was a potential \$750,000 economic grant. Ms. Jain reviewed the timeline. Inspections were discussed.

The motion carried unanimously, 6-0. (D'Avanzo, Drew, Elletson, Manchisi, McCarthy, Steiner in favor)

g) Preliminary: To hear, consider and act on a request for funding for Construction Administration, Daily and Specialized Inspection and "Re Design" Services during Construction for East Trunk Sewer Line for \$700,000.

Mr. Hurley reviewed timing and noted it will go out to bid next month.

Joseph D'Avanzo motioned to move Item (g) to a date certain our November 16, 2022, meeting. Tom McCarthy seconded the motion which carried unanimously, 6-0. (D'Avanzo, Drew, Elletson, Manchisi, McCarthy, Steiner in favor)

h) FUTURE Construction Estimates \$5M for wetlands crossing, \$8-10mM for East Trunk Sewer Line. (paving/Laterals)

This was covered in earlier items. Mr. Hurley added recommending soil testing.

4. Old Business

- a) Digester update began dewatering today. No update on the insurance claim.
- b) Pool water discharge policy no update, haven't heard back from SHU.

5. Update on Current Projects

The hardening project is not complete. They have to finish the pump station behind the Conservation building and the Fire Training School.

Carriage Drive has not gone out to bid.

6. Status Update on Sewer Bypasses – There were none.

7. Adjourn

Tom McCarthy motioned to adjourn the meeting at 9:13 p.m. Matt Manchisi seconded the motion which carried unanimously, 6-0. (D'Avanzo, Drew, Elletson, Manchisi, McCarthy, Steiner in favor)
