To hear consider and act on authorizing the Purchasing Authority to enter into the proposed contract between the Town of Fairfield and Altumint, Inc of Lanham, MD to implement and maintain an Automatic Traffic Enforcement Safety Device Program as detailed in Town of Fairfield RFP# 2025-60R, and the Altumint Submission dated May 28, 2025 for an initial base term not to exceed three (3) years, with additional authority to enter into future extensions with similar terms and conditions upon mutual agreement.
