## 1. Essex Street At/Between Brookfield Avenue

Nature of Request: Stop Sign at South end of Essex Street and upgrading Dead End Sign

By Whom: Grace Calderon (Please see attachment for Details)

- Recommendation to Consider:
- 1. Dead- End Sign should be replaced with a New Sign on both sides
- 2. Further Volume and Speed Data analysis required to analyze Cut Thru Traffic before installing a Stop Sign.

## 2. Kings Street At/Between Moody Avenue

Nature of Request: Stop Sign at the South End of King Street Intersecting Moody Avenue

- Recommendation to Consider:
- 1. Further Volume and Speed Data analysis required of the area for Cut Thru Traffic before installing a Stop Sign
- 2. As per site visit a DO NOT ENTER Sign was found at Moody Avenue. The reason of placing this sign by whom and the Date is unknown. If DO NOT ENTER sign was approved by LTA in the past then it should be replaced with MUTCD compliant DO NOT ENTER Sign and Diagonal Diverter should be considered.

# 3. Church Hill Road & Falmouth

Nature of Request: Stop Sign request at Falmouth Road Intersecting Church Hill Road.

## Recommendation to Consider:

As per Site Visit Falmouth is a Dead-End Street. To enforce the drivers to grant Right of Way to the Drivers at Church Hill Road a STOP Sign should be considered.

#### 4. Stratfield Road (CT Rt. 59) At/Between Louvain/Bond Street Intersection.

<u>Nature of Request</u>: Stop for Pedestrian in street Sign request at Louvain/Bond Street Intersection.

The Stop for Pedestrian in street Sign on Stratfield Road (Rt. 59) at Louvain/Bond Street Intersection will meet MUTCD conditions. (Please see the attachment for the details).

- a.) Kings Highway East in between New England Avenue and Constant Comment/Timko Street.
- b.) Ash Creek Boulevard near Metro Center Commuter Lot entrance

Please note these were approved by Engineering Manager, Police Chief and First Selectman but not sure if approved by LTA, so requesting formal approval before structures features are installed. Project # 0173-0547, State Town Muni project for RRFB and Crosswalk/Handicap Accessible Ramps. The State Contractor installed project includes State/Feds covering all installation costs including Design/ Build components for the listed locations. The State Contractor will review locations in the field.
