4-Lot residential subdivision with associated infrastructure within a Regulated Area. Decision may be made if the hearing is completed, or the hearing may be continued. The original 35-day public hearing timeframe to complete the hearing ends on June 11, 2025. A 56-day time extension was provided by the applicant.
