**SURVEY #1 LOCATION:** School Zones Approval for OSTA

**NATURE OF REQUEST:**

Pursuant to Connecticut General Stature 14-212b, requesting LTA approval to implement an Office of State Traffic Administration (OSTA) approved School Zone for Dwight School, Riverfield School, Burr School, Notre Dame School, Ludlowe High School, and Warde High School.

**SURVEY #2 LOCATION:** Church Hill Road between Easton Turnpike and Fairfield Woods Road

**NATURE OF REQUEST:**

Engineering is requesting to paint edge lines from Easton Turnpike to Stratfield Road and Church Hill Road to keep 10' wide travel lanes on both sides. The edge line should be 7" max. wide travel lanes on both the sides.

The edge line should be 7' max wide from the edge of the curb or roadway and shall not exceed the width of 7'.
