 - a. **SURVEY #1 LOCATION:** Fairfield Beach Road at/between Dead End

NATURE OF REQUEST:

Install "No Parking Tow Away Zone (Fine \$200.00) signs on Fairfield Beach Road at the Dead End along the entire sea wall along with updating all other signs at the Dead End for "No Parking Tow Away Zones" as already posted. Remove any signage that is not approved by the LTA and Town of Fairfield in the area related to parking

RECOMMENDATION:

Remove existing "Resident Only Parking" signs on Fairfield Beach Road.
Install four (4) "No Parking Tow Away Zone (Fine \$200.00) signs on cement retaining wall at Fairfield Beach Road at the Dead End.

- b. **SURVEY #2 LOCATION:** Judd Street at/between Burroughs Road

NATURE OF REQUEST:

Vehicles routinely parked on Judd Street in front of #223 and #225 Judd Street located at the intersection with Burroughs Road on the opposite side, forcing eastbound Judd Street traffic into the westbound travel lane at the same time vehicles are turning from Burroughs Road onto Judd Street. I believe this condition poses a significant safety issue.
Request for "No Parking" signs on Judd Street in front of #223 and #225.

RECOMMENDATION:

Deny – Area is already within the No Parking Zone at intersection.

c. **SURVEY #3 LOCATION:** Knapps Highway at/between Tunxis Hill Cut-off and Black Rock Turnpike

NATURE OF REQUEST:

Neighbors parked vehicle was struck by a car speeding down Knapps Highway. This has been a regular occurrence since moving here almost four years ago. I believe fog lines and rumble strips that are currently being added to Redding Road could benefit this portion of Knapps Highway. The road is very wide to accommodate street parking, but residents currently risk their vehicles being struck and as a result few people park on the street. This gives drivers a very wide-open road, which encourages exceeding the speed limit.
