SURVEY # 1 LOCATION: Judd Street at Stillson Road

#### NATURE OF REQUEST:

Request new crosswalk - a clearly marked crosswalk would visually highlight potential pedestrians to drivers.

Request "Pedestrian Crossing" or "School Zone" signs. These signs on both Judd Street and Stillson would explicitly alert drivers to the presence of pedestrians and potentially slow traffic. Request visual cues similar to North Benson and Stillson Road also in Osborn Hill School zone.
