Hannah Gale, Dist. 6 stated that although she is supportive of giving firefighters tools to protect their health, she is concerned about consent being taken away in terms of mandatory screening for PSA tests and mammograms.

Tom McCarthy, District 7 asked for a brief summary of the changes to OPEB and medical.

Emmet Hibson, HR Director explained the insurance premium cost share increased 1% each year. For new hires – eliminate pension at 30 years regardless of age, increase pension eligibility age from 51 to 56 with a minimum of 25 years of service (currently 25 years of service and age 51 or 30 years of service). Increased employee pension contributions by .25% each year effective July 1, 2018.

§78-3. EXCESSIVE NOISE PROHIBITED.

IT SHALL BE UNLAWFUL FOR ANY PERSON TO EMIT OR CAUSE TO BE EMITTED ANY NOISE FROM SUCH PERSON'S PROPERTY BEYOND THE BOUNDARIES OF HIS PROPERTY LINES IN EXCESS OF THE NOISE LEVELS SET FORTH IN §78-5 DURING THE NIGHTTIME HOURS AS DEFINED IN §78-2, EXCEPT IN THOSE INCIDENCES PROVIDED FOR IN §§ 78-8 AND 78-9. "NIGHTTIME HOURS" SHALL MEAN THE HOURS BETWEEN 10:00 P.M. AND 7:00 A.M., SUNDAY THROUGH THURSDAY, AND 11:00 P.M. AND 8:00 A.M., FRIDAY AND SATURDAY.

§48-1 REMOVAL OF FECES REQUIRED

IT SHALL BE UNLAWFUL FOR ANY PERSON OR PERSONS OWNING, KEEPING, OR HAVING CARE CUSTODY OR CONTROL OF ANY DOG TO ALLOW OR PERMIT SUCH ANIMAL TO DEFECATE ON ANY PRIVATE PROPERTY OWNED BY ANOTHER PERSON, OR CONDOMINIUM COMMON ELEMENTS OR ANY TOWN PROPERTY WHATSOEVER, INCLUDING BUT NOT LIMITED TO PARKS AND SCHOOL GROUNDS, UNLESS SUCH PERSON SHALL IMMEDIATELY REMOVE ALL FECES SO DEPOSITED BY SUCH ANIMAL AND DISPOSE OF SAME IN A PROPER MANNER.

§48-2 EXCEPTIONS.

THE PROVISIONS OF THIS ARTICLE SHALL NOT APPLY TO A GUIDE **OR SERVICE DOG** ASSISTING A BLIND, HEARING IMPAIRED OR MOBILITY IMPAIRED OR DISABLED PERSON.

§48-3 PENALTIES FOR OFFENSES.

EACH VIOLATION OF §48-1 OF THIS ARTICLE SHALL BE PUNISHABLE BY A FINE OF \$25100.

During any state or national holiday, the weekend schedule will be in effect from the previous evening before the holiday through the end of morning of the holiday.

§ 78-3. Excessive Noise prohibited.

§48-3 Penalties for offenses.

Each violation of §48-1 of this article shall be punishable by a fine of \$25 100.

RTM Public Works and Planning Committee Minutes September 18th 2017

9:09pm the meeting was called to order by Chairman Robin Orriss.

Agenda item 11. Noise Ordinance: Consensus favorable. Rep Georgiadis felt the fine for a violation should be more money. The ordinance calls for a \$50 fine for the first offense, and a \$90 fine for a second offense. However, it was agreed that if the ordinance is passed, she could address this issue at another time.

Agenda items 4 and 5. Fair TV, Holland Hill Building Committee: Consensus favorable for all appointments. Todd Chandler, Andy Jones to Fair TV, and Berkeley Murray to the HH Bldg Committee.

Agenda item 3. Disorderly Conduct ordinance (fines for landlords) Chief MacNamara presented. Rep. Pine brought up the State Nuisance Abatement Law, and its applicability to certain properties, specifically the now closed "Hookah Lounge". Since the business is now closed it is a moot point. Consensus favorable.

Agenda item 7. Youth Services Grant: Anthony Calabrese, Director of Parks and Recreation presented. Believes Youth Services is very important and if the Grant is not funded, the money will come out his budget. Consensus favorable.

Agenda item 6 Fire Union Contract. HR Director Emmett Hibbs presented. Wages appear in line with other Fairfield County municipalities. Inflation as of August 2017 was 1.9%, and may reach 2.3% by years end. 2% raise seems appropriate. Also considered; the RTM just approved a 2.0% increase for the nurse's contract. Increase % for medical premiums. Increase retirement age from 51 to 56. Pension contributions seem low compared to other towns @5.5%. However, overall the contract seems fair to both the Fire Fighters and the town. Consensus favorable.

Agenda item 8. Firefighter FEMA grant. Chief McCarthy presented and explained that it is in the best of interest of the town to have our fire fighters in top mandatory shape. This grant would assure this. Consensus favorable.

Agenda items 9 and 10. Valley Road Bridge, and Kings Highway Pedestrian Improvement Bonds. Town Engineer, Bull Hurley presented. Reimbursement of a large percentage of the cost makes these bond resolutions palatable. These improvements should add 50-75yr life span to these structures. Consensus favorable.

Agenda item 12. Animal Ordinance (poop law). Increase of fine to \$100.00, for failing to remove animal waste from town or private property. Consensus favorable.

A motion was made by Chairman Orriss to adjourn the meeting. Second by Representative Pine. Vote 6 for 0 opposed. Motion carried. Meeting adjourned at 9:23pm
