# Call to Order

# SUBJECT: New Transfer Station Fees Effective July 1, 2024

Tip fees charged to haulers and fees charged to homeowners bringing Municipal Solid Waste (MSW) to the Fairfield Transfer Station (TS) have not increased since July 2014 and July 2015, respectively. TS operating expenses during this time have increased steadily, and as part of a new five-year contract, beginning July 1<sup>st</sup>, 2024, WIN Innovations/Wheelabrator have increased tip fees to Fairfield for bringing MSW from the TS to the Bridgeport trash-to-energy plant by about 22%. The increase from WIN will result in approximately \$475,000 increased expenses to Fairfield for FY2025.

Accordingly, in a Special Meeting on April 15<sup>th</sup>, 2024, the SWRC voted to increase fees to haulers and residents as outlined in the following Pages 2 & 3. These new fees will be listed in Chapter 4 of the revised Solid Waste & Recycling Regulations, now under review.

# **CHAPTER 4: SCHEDULE OF TRANSFER STATION & COLLECTION FACILITY FEES**

## Fees in Sections 4.1 through 4.3 below were approved by the Solid Waste & Recycling Commission in a Special Meeting on April 15<sup>th</sup>, 2024

# 4.1 Annual Licenses - Effective July 1<sup>st</sup> each year;

## 4.1.1 Garbage & Rubbish Vehicles, Expiration Date June 30th each year

- Chassis-Mounted Body \$150.00 per year
- Roll-Off Transport Motorized Vehicle \$150.00 per year
- Roll-Off Container \$100.00 per year
- Recycling Vehicle Commercial and Residential \$150.00 per year
