## **Residential Single Family:**

-74 gal times 2.61 People =193.14 gal/ per day New Rate = 28.88 per gal New fee per unit = \$5577

#### One Bedroom / Studio Unit

-74 gal times 2.25 People =167.0 gal/ per day New Rate = \$28.88 New per unit= \$4822

#### **Two Bedroom Unit**

-74 gal times 2.61 People =193.14 gal/ per day New Rate = \$28.88 New per unit= \$5577

#### **Three Bedroom Unit**

-74 gal times 3.915 People =289.71 gal/ per day New Rate = \$28.88 New per unit= \$8,366

A new fixed charge (see table below) will be accessed to any developer who does not provide "flow monitoring" data, when requested by the Commission

The fixed charge is as follows: \*
20 units or fewer: \$10,000
20-50 units: \$15,000
Greater than 50 units:\$20,000

\*This charge will be waived, if the developer provides the flow data with their associated capacity study.
