

Nature of Stockpile Materials – Soil, asphalt and millings, concrete


- Constituents of Concern (COCs) Arsenic & lead, ETPH, PCBs
- CT DEEP Remediation Standards Regulations -Direct Exposure Criteria (DEC)



- Health & Safety Issues Soils tested before relocation for safety
- Data posted and discussed at weekly job safety meetings
- Air testing performed to ensure no worker exposure issues
- Air testing good (no COCs above laboratory analytical detection level)



#### Soil Testing Grids






#### ➤ Soil Criteria:

Meets Residential DEC: Use as topsoil or anywhere berm

- Above Residential DEC / below Industrial/Commercial DEC: Use in core of Berm
- Above Industrial/Commercial DEC: Remove from site – <u>None found thus far</u>


- Do we need fence?
- Will the new berm height (elevation 45') serve the screening purposes?
- Need to make the decision in a couple weeks for FY 18 budget purposes.

### HARDENING PROJECT

A Flood Control Structure to protect against waters of Long Island Sound.

- Protects Wastewater Treatment Plant, Fire Training Grounds, Animal Control, Conservation Garage.
- The above facilities will also be served by a common generator system (Microgrid).
- Would like to proceed with an application to P&Z.







# HARVEST NEW ENGLAND

- March nor'easters created a spike in the amount of material at the site, just returning to normal operations.
- Site continues to be monitored for pile height & temperatures.
- No fire since incident of 2/12/18, extinguished within one hour.
- > Berm now provides shielding to the south.

# LEGAL

The Town is in legal action versus Julian utilizing outside legal council. All available options are being pursued.

The Town is seeking to recoup all expenses and damages for the contamination and for the amount of material on site.

## FOLLOW UP

Substantially completed berm by 6/30/18. (Some plantings may be deferred as growing season ends)

Submit application and obtain final approvals for Hardening Plan.

Continued feedback from neighbors on development of 5-yr plan.

Continue to provide bi-weekly Status Updates to Neighbors/ Regular Scheduled Bi-monthly Meetings
