



Dear Fairfielders,

THIS IS AN IMPORTANT UPDATE: Due to a court delay in the sentencing date for Jason Julian, the deadline to file victim impact statements in the Town's fill pile criminal case has been extended. You now have until Tuesday, February 6 at 4 p.m. to submit your statements for Jason Julian.

The deadline to submit impact statements for Emmet Hibson and Brian Carey is unchanged: Friday, February 2.

To recap:

The Town of Fairfield hired a contractor, Julian Development, to operate the Town's fill pile and reduce the amount of unused project material on the site. After several years, it was discovered that the fill pile had more than tripled in size—from 30,000 cubic yards to approximately 107,000 cubic yards—and that the company had accepted contaminated fill, including toxins such as PCBs, lead, asbestos, and other hazardous material. The criminal investigation discovered that the contaminated fill was subsequently used at more than 40 sites in Town and was used under the foundation of the rebuild of Penfield Pavilion.

Several town employees have been convicted of criminal charges for their involvement, and others now have upcoming criminal proceedings.

For Jason Julian:

In December 2023, **Jason Julian** pled guilty "to multiple charges related to environmental crimes associated with contaminated material disposed illegally at public property." Under Jason Julian's plea agreement with the state, he agreed to be sentenced to 18 months in prison and pay \$2.5 million in restitution to the Town of Fairfield. Jason Julian will be sentenced on Wednesday, February 9,

2024, at 11 a.m. The sentencing will occur at the Bridgeport Superior Court, Courtroom 3A, 1061 Main Street, Bridgeport, CT.

For Emmet Hibson and Brian Carey

Emmet Hibson, former Fairfield Human Resources Director, and Brian Carey, former Fairfield Conservation Director, have pending motions for reconsideration of their applications for accelerated rehabilitation that will be heard on Monday, February 5, 2024, at 11 a.m. These applications for accelerated rehabilitation were previously denied by the Court. The hearing will occur at the Bridgeport Superior Court, Courtroom 3A, 1061 Main Street, Bridgeport, CT.
