#### **TOWN GOVERNMENT**

#### **SURPLUS, FILL PILE CONTAMINATION & REMEDIATION**

On Tuesday night, the Board of Finance (BOF) met to discuss the Town's \$9.3 million surplus, which was largely created from the Town budgeting for a lower tax collection rate than was actually collected. The Town also achieved savings on the expense side, mostly due to lower personnel costs. The BOF voted to transfer \$1.3 million of the expense surplus to contractual commitments for the retired Town employee healthcare fund. This left approximately \$1.7 million of the \$3 million expense surplus that they voted to transfer to the Town's Fund Balance.

During the meeting, I provided the Board of Finance with an update on the ongoing expected costs related to the fill pile contamination and public corruption that occurred under the former administration. While it would have be my preference for the Town to use the remaining approximately \$6 million in revenue surplus, to reduce the tax burden on our residents, I felt it was important to recommend the remaining surplus be deposited into the Town's fill pile fund, towards the mounting costs for remediation.

The projected contamination costs that I presented are estimates based on preliminary evaluations by environmental consultants, but even at the low end of the range of costs, the numbers are staggering. You can watch the outline I gave to the BOF <a href="here">here</a>. I will be bringing the item for a vote before the Board of Selectmen on October 18 and I will ask the BOF and RTM to do the same.

#### CHARTER REVISION

I was very disheartened by the recent politicization regarding the Charter Revision Commission (CRC) by some elected officials and members of our community. I hope that we will *all* keep an open mind throughout this process, and listen to *all* ideas that come forward. I certainly will, because this is a genuine effort to improve Fairfield's governing document.

It was not my obligation under State Statute, but rather my decision, to appoint a balanced commission that consists of 3 Democrats, 3 Republicans and 1 unaffiliated member. For some to suggest that this process is somehow tainted, while it has just started, is unfortunate. I appreciate and respect these residents who have stepped forward and agreed to volunteer their time on the CRC in service to our community.

I want to remind our residents that the point of this commission is for everyone in our community to bring forth ideas and suggestions. You may feel there are no changes needed, and that's okay too. I've provided a link to the charter below, that you may find helpful to review. I will be making recommendations to the commission based on my experiences over the last two years, including making sure our Charter aligns with the Town Code, re-examining purchasing and contract oversight, and ensuring sure we have *all* the government we need, but *only* the government need. Our Town Attorney and department heads will similarly be making recommendations.

While the Board of Selectmen will be presented recommendations to vote on from the CRC, the ultimate decision on any changes to our Town Charter will be up to all residents of Fairfield on the 2022 Election Day ballot.

The CRC held its second meeting on Wednesday evening, which was a public hearing to receive feedback and recommendations on changes to the Charter. You can watch the public hearing here.

#### **Fairfield Town Charter**

#### AMERICAN RESCUE PLAN ACT FUNDING UPDATE

My proposal to the Town boards to spend the \$24.8 million in federal funds has been approved, and my administration is now working to get these projects off the ground.

We put together a comprehensive package that will have a broad impact on our community – some urgent and long neglected needs like Rooster River flooding mitigation, downtown flooding in the business district, funds to pave roads in disrepair, and fix or connect sidewalks. Additionally, the funding for the Police Department's body and dash cameras over the next 10 years will put the Town in compliance with recent State legislative mandates and will take pressure off the Town's annual operating budget.

Other projects include a study for beach erosion and coastal resiliency, funding for air conditioning at Fairfield Woods Middle School, ADA compliance, upgrades for the Bigelow Center for Senior Activities (including a new outdoor patio), new playgrounds for multiple neighborhoods across Town, and funding for nonprofits, to address the growing mental health and financial hardships as a result of the pandemic. There is also \$1 million appropriated toward the mounting costs associated with the remediation and cleanup from the ongoing fill pile catastrophe. Some of the items on the list will also provide savings in future Town budgets and projects that were on the long-term capital plan that will reduce debt service.

I am grateful for the tremendous amount of feedback and input from our residents over the last two months. It has been almost two years since I took office and there have been many challenges, but I have been listening and I will continue to do my best for our community.

#### **COVID-19 UPDATE**

#### **MASKS**

Last Friday I sent an interim update announcing my decision to lift the Town wide mask mandate. You can read the information <a href="here">here</a>. This decision was made in consultation with our Health Director and Emergency Management Director, after seeing a consistent downward trend across case rates and hospitalizations, and an increase in our community's vaccination rate. Fairfield's current positivity rate is 1.1% and yesterday the Town was downgraded to the <a href="yellow">yellow</a> category. Connecticut's seven-day positivity rate dropped to 1.7%. Hospitalizations in Fairfield County are down to 37, 18 less than when we lifted the mandate last week.

The Town is following the CDC guidance that *recommends* masks be worn indoors and when in close contact with others.

Some residents have written in saying the decreasing trends are evidence the mask mandate worked. And while I respect and understand why one would draw that conclusion, I would just say that there are many towns in our state that don't have mask mandates in effect and have similar or lower case rates than Fairfield. We are monitoring trends not just as a Town, but also as a county, state and country.

The NY Times published an update this week that said the number of new daily cases in the U.S. has fallen 35 percent since Sept. 1 and worldwide cases have dropped more than 30 percent since late August. Read the full article, "Covid, in Retreat".

I continue to ask residents to please be respectful to each other, regarding differences of opinion regarding masks, because in the end, we are all neighbors and are all dealing with the added stress this pandemic has caused in different ways.

#### **BOOSTER (3RD VACCINE) INFORMATION**

Currently, the Fairfield Health Department is NOT hosting any COVID-19 vaccination clinics. If clinics are scheduled, be sure to follow our social media accounts and news section on our website for updated information.

# Booster (3<sup>rd</sup> shot) COVID-19 Vaccine for those who are moderately or severely immunocompromised ONLY

Effective August 13, 2021 the CDC has recommended that individuals who are moderately or severely immunocompromised and received either Pfizer or Moderna,

are eligible to receive a third dose of either Pfizer or Moderna, if it has been at least 28 days since their second dose. Eligible individuals include:

- · Active treatment for solid tumor and hematologic malignancies
- · Receipt of solid-organ transplant and taking immunosuppressive therapy
- Receipt of CAR-T-cell or hematopoietic stem cell transplant (within 2 years of transplantation or taking immunosuppression therapy)
- Moderate or severe primary immunodeficiency (e.g. DiGeorge syndrome, Wiskott-Aldrich syndrome)
- Advances or untreated HIV infection
- Active treatment with high-dose corticosteriods (i.e.,>20mg prednisone or equivalent per day), alkylating agents, antimetabolites, transplant-related immunosuppressive drugs, cancer chemotherapeutic agents classified as severely immunosuppressive, tumor-necrosis (TNF) blockers, and other biologic agents that are immunosuppressive or immunomodulatory.

# Booster (3<sup>rd</sup> shot) COVID-19 Vaccine for those who received Pfizer Vaccine ONLY

On September 22, 2021 the FDA amended the emergency use authorization (EUA) for the Pfizer vaccine ONLY. Individuals who received Pfizer are eligible to receive a single boost dose as long as it has been at least 6 months since their second dose. Eligible individuals include:

- individuals 65 years of age and older
- individuals 18-64 years of age at high risk for severe COVID-19
- individuals 18-64 years of age whose frequent institutional or occupational exposure to SARs-CoV-2 puts them at high risk of serious complications of COVID-19 including severe COVID-19

# Booster (3<sup>rd</sup> shot) COVID-19 Vaccine for those who received Moderna or Johnson and Johnson

While we anticipate there will be at some point, at this time, there is no approval for a Moderna or Johnson and Johnson booster (3<sup>rd</sup> dose) vaccine. The FDA is scheduled to meet later this month to approve a potential booster shot for individuals who received Moderna or Johnson and Johnson.

While the health department does not currently offer any booster clinics for those who are immunocompromised or those who received the Pfizer vaccine, you can check the local pharmacies as they are currently giving these out. The health department will continue to monitor the approval process.

## POLICE DEPARTMENT LAUNCHES APP FOR RESIDENTS TO PLACE ANONYMOUS TIPS

The Fairfield Police Department is increasing its crime-fighting arsenal with a new app to help residents connect with the department to find information and submit anonymous tips from their smartphone.

The new **Fairfield PD** app enables the public to share an anonymous tip with police and lets officers respond back to create an anonymous two-way conversation. The **Fairfield PD** app and Tip411 anonymous text a tip system are 100% anonymous, as the technology removes all identifying information before police see the tips and there is no way to identify the sender.



The **Fairfield PD app** is available for download for free via the Google Play Store, iTunes App Store or on their website at <a href="https://fpdct.com/tips">https://fpdct.com/tips</a>. Those without a smartphone can share information with police by sending an anonymous text tip via their cell phone to police by texting keyword **FPDCT** and their message/tip to **847411** (tip411). #### **CAMPAIGN SIGNS**

Candidates and political parties have been advised by law enforcement that lawn signs are not allowed to be placed on public or Town property and should only be placed, with permission, on private property. In accordance with zoning ordinances, they cannot be affixed with ties, rope, string to mailboxes, street signs, or stop signs.

#### **ABSENTEE VOTING**

If you will not be able to make it to the polls on Election Day – November 2, 2021 - you may vote absentee by mail. Absentee Voting is permitted in the State of Connecticut for any of the following reasons:

VOTE BY ABSENTEE

BALLOT

- physical disability
- illness
- absence from the Town during all of the hours of voting
- religious tenets which forbid secular activity on Election \* \* \*
   Day
- Pursuant to Senate Bill 1202, of the June Special Session 2021, COVID-19 may be used as a valid reason for requesting a ballot for any election held before November 3, 2021

Absentee voting in Connecticut is a two-step process. A completed and signed <u>Absentee Ballot Application</u> or <u>Spanish Absentee Ballot Application</u> must be filed with the Town Clerk before a ballot is issued.

Applications may be filed in person, by mail, or by e-mail. If **filed by e-mail, the original, signed application must be returned with the ballot**, **or by mail**, to the Town Clerk's Office, 611 Old Post Road, Fairfield 06824 by Election Day for the ballot to be counted.



- Pay landlords for 100% of covered arrears, rather than only 85%
- Cover 3 full months of prospective rent
- Protect tenants from evictions for nonpayment of rent during the months covered by the prospective rent payments
- Continue to consider waiving the \$10,000 limit on rent assistance, on a case by case basis, for households with extenuating circumstances
- Rely where possible on information about an applicant's enrollment in other state programs to streamline the application process

Additional Utility Assistance Through CEAP: Connecticut Energy Assistance Program (CEAP) is underway for 2021/2022. If you are unable to apply for energy assistance on your own, you may also apply with the help of the Department of Social Services beginning September 1<sup>st</sup>. Please call 203-256-3170 to make an appointment.

Emergency Lien Assistance Program: Beginning October 1 Public Act 21-44 will establish an emergency lien assistance program within the Connecticut Housing Finance Authority's Emergency Mortgage Assistance Program. The program is designed to offer loans to homeowners facing foreclosure due to liens from municipal water or sewer charges, municipal tax debt, or association assessments and fines accrued at condos and similar types of housing.

Important Change for SSI Recipients and Applicants: The Social Security Administration (SSA) recently changed its rules about how pandemic-related financial assistance is considered, such that it will no longer count pandemic related financial assistance against an applicant's eligibility or benefit amounts. The SSA is now reviewing applications, redeterminations, appeals, and other records going back to March 2020. To access or restore benefits, you do not have to wait to be contacted. The Fairfield CARES Community Coalition, the Local Prevention Council for the town of Fairfield, is pleased to announce that, in partnership with Fairfield Public Schools, it has received a five year federal <a href="Drug Free Communities Grant">Drug Free Communities Grant</a> of \$625,000 from the Centers for Disease Control and Prevention. The grant, allocated at \$125,000 per year, will take effect on September 30, 2021, and will provide funding to prevent and reduce youth alcohol and cannabis/marijuana use, the two most frequently used substances by youth in Fairfield.
