

Introduction

Thank you to everyone who completed our Southport Harbor Questionnaire.

We received a total of 373 full responses, summarized on the following slides, to our questions. Included were questions concerning how people enjoy the harbor; which harbor management issues are most important; and what the priorities should be for managing the harbor.

In addition, many respondents took time to add their own thoughtful observations and suggestions, showing how much the harbor means to them. Those observations and suggestions are presented in their entirety in the attachment to this presentation.

The questionnaire's purpose was to inform the community about our work to update the Town's Southport Harbor Management Plan and to gather helpful input as we update the plan and pursue other initiatives in 2021.

When reviewing the results for each question as presented on the following slides, please note that the top bar on each chart always represents the multiple-choice answer that received the greatest number of responses to the particular question.

Introduction (Continued)

When reviewing the responses, it's interesting to find that while Southport Harbor is an important center of recreational boating activity, "enjoyment of water views," "shoreline walking," and "nature observation" were the harbor activities most identified by the respondents.

Most agree with the Harbor Management Commission's priorities of updating the Harbor Management Plan; finding a way to reduce the amount of sand building up in the channel alongside the jetty; working with the Corps of Engineers to restore the full width of the harbor entrance channel; and completing the Lower Wharf dredging and boat ramp improvement project.

We look forward to hearing more from the public throughout the year as we continue our vital mission to guide safe and beneficial use of the harbor and protect the harbor's coastal resources.




Q1 Where do you reside?




Q2 What is your age?




Q3 How do you enjoy the harbor? Please tell us about how you enjoy Southport Harbor. Check as many of your activities as apply.



Q4 How do you access the harbor? Please tell us how you get physical and/or visual access to Southport Harbor. Check as many access locations as apply.












Q11 Please describe any additional harbor management focus areas of interest to you.

A number of the 128 additional comments that we received included specific environmental and public safety recommendations, including, most notably, recommendations to:

- Monitor and protect **environmental integrity and natural habitat** with particular attention to avoiding pollutants such as fertilizers running off into the harbor, and protecting fish, waterfowl, other birds, terrapins, and all wildlife;
- Improve **harbor area safety** sometimes affected by vessel speed, kayaking in congested areas, vehicular and bicycle traffic on roads near the harbor, and people and dogs swimming in the navigation channel; and
- Increase **trash disposal** facilities for general trash <u>and</u> dog waste, especially at Perry Green, Lower Wharf, and the Town Boat Yard.




Q12-15 What do you think of the following priority harbor improvement initiatives?


Q12 Update the Harbor Management Plan, and include in the plan a "sand management" strategy to reduce the amount of sand building up in the entrance channel alongside the jetty.





A number of the 83 responses to this question expressed satisfaction with harbor conditions and the way the harbor is managed, and again emphasized the importance of maintaining a clean and safe harbor enjoyed by everyone.

Other notable response themes concern the need for regular dredging in the harbor, particularly at the sand bar at the entrance to the harbor; the need for maintenance of town facilities at the Town Boat Yard and Lower Wharf, including placement of more trash cans; and requests for additional facilities for paddlers and for the Community Sailing program.

The Harbor Management Commission is appreciative that a number of the 59 respondents who provided concluding remarks expressed support and encouragement for the Commission's efforts to manage safe and beneficial use of the harbor and protect the harbor's exceptional resources.

When pursuing its programs in accordance with the Harbor Management Plan, the Commission strives to always serve the overall public interest, recognizing that the harbor's submerged lands and waters are part of the public trust area of the State of Connecticut; that the harbor is served by a congressionally authorized federal navigation project that must be open to all; and that waterfront property owners have important rights for reasonable access to navigable water.
