## **BUILDING PERMIT FEES – Effective 05/01/11**

The following table, adopted by City Council Resolution #1097, and as modified by City Council Resolution #1648 and #2121, can help you calculate and determine your building, electrical, mechanical, fuel gas, plumbing, and miscellaneous permit fees.

In calculating fees, remember the City of Golden assesses a 3% use tax on building materials (1.5% of total valuation). There may also be an additional plan review fee of 65% of the permit fee.
