VILLAGE PRESIDENT

Happy Fall Greenville! What a busy summer it has been. Our Village Staff has been working to complete some significant projects around the community. The work you are seeing just south of the STH 76 & STH 15 intersection is the final work needed for critical sewer lift station renovations. Yes this is the same project that had parts of Municipal Drive blocked off this past spring, but I am happy to say we should see it complete in the next few weeks. The project on Greenwood Road will soon be getting its first layer of asphalt. I'm certain those living next to or near the project will be thankful to have the roadway back and fully open. It should be noted the final layer of asphalt will not be applied until the weather warms next spring. This has been in the plans for the project all along as it allows any settling to occur and be resolved before the final layer of asphalt is applied. Combined these two projects had a budgeted price of nearly \$7M and took over three years to plan and execute. Projects like the lift station renovations and road improvements are not taken lightly by the Village Board or Village Staff. Often we only hear the voice of the cynical critics regarding the decisions made in our community and the work being done, so I thought I would give a little insight into the process for budgeting in our community.

The annual budget process is a year-round activity for the Village with focused efforts through the summer months to review the rolling 5-year Capital Improvement Plan (CIP) moving along to budget workshops in September & October. Then culminating with approval of the following year's budget in November. The CIP is a forwardlooking list of potential project and asset spend recommended to the Village Board by Staff. It is important to point out just because a project or asset spend is listed on the CIP it doesn't mean it is approved to happen. This is what the budget workshops help determine. During these workshops the Village Board is challenged to deliver all the desired services, whether statutorily required or discretionary, to the community using a finite dollar amount known as the tax levy. With the final goal of the budget workshops being to produce a balanced budget, meaning revenues equal expenditures, it is very challenging to determine what stays in the budget and what doesn't. In addition, the Village Board needs to analyze what quality level of a particular service we need to provide. The higher level of quality provided for a service the more it costs. For example, I have been hearing more and more about the need for additional law enforcement in Greenville. Added law enforcement comes with added costs. Currently, in addition to the already provided sector officers, Greenville contracts with Outagamie County Sheriff's Department (OCSD) for one full-time officer to be dedicated to the community. The cost for the dedicated officer is approximate \$112,000 to Greenville. Each additional dedicated officer would cost a similar amount. If we as Village Board determine an additional dedicated officer is needed through OCSD, we in turn need to determine what service is going to be downgraded or no longer provided to make up the \$112,000 difference. As you can imagine, agreeing to a balanced budget takes much negotiation and compromise between Village Board Trustees as well as Village Staff. It is not something any of us take lightly as we area all citizens and taxpayers of Greenville just like each of you.

As former Village Trustee Joe Ryan will tell you, being a member of the Village Board isn't easy. No matter what you decide or the direction you take, you always seem to upset one or many people. There is definitely some truth to the old saying, "You can't make everyone happy." I ask you to continue to speak your mind when it comes to issues and concerns of our great community, but to be mindful to do so with emotions in-check. Don't hide behind social media but come and have a conversation with us whether one-on-one or at any of our open meetings where you and your neighbors are always welcome.

I'll end with the words of Theodore Roosevelt, "The Man In The Arena" a speech he delivered in Paris, France April 23, 1910. "It is not the critic who counts, not the one who points out how the strong man stumbled or how the doer of deeds might have done them better. The credit belongs to the man who is actually in the arena, whose face is marred with sweat and dust and blood; who strives valiantly; who errs and comes short again and again; who knows the great enthusiasms, the great devotions, and spends himself in a worthy cause; who, if he wins, knows the triumph of high achievement; and who, if he fails, at least fails while daring greatly, so that his place shall never be with those cold and timid souls who know neither victory nor defeat."





Apply for Permits Online

Greenville has invested in developing a new permitting system which has an online application component with the ability to pay online. The system was launched in April 2021 and allows the public to apply for building permits (i.e. new house, fence, deck, patio, additions, remodels, etc.), development requests (i.e. rezoning, site plan, plats, special exceptions etc.) and permit types that require work in the public right-of-way (i.e. culvert, driveway, utility etc.).

STORMWATER

Draining Your Pool?

Taking the time to follow the proper procedures when draining the water from your pool or spa will help keep our local waters a healthy place for fish and other aquatic life to live.

Leave Your Leaves

Properly cleaning up your yard in the fall will help keep our local waters clean too! A great way to do that is to keep them right on your property. Try mulching your leaves in place by making several passes over them with a mulching mower. This will keep leaves on your lawn and provide it with nutrients it needs for healthy arass next sprina. You can also collect mulched leaves and spread them in garden beds or under shrubs. Leaves provide valuable protection for plants through the winter and also provide nutrients for spring growth.

- De-chlorinate the Water: Let the water sit for at least one week to reduce the chlorine or bromine level.
- Discharge Water to Grass or Landscaping: Discharging the water onto grass or landscaping will allow the water to soak into the earth, where it will be naturally cleansed prior to enterina local waterways.
- Monitor the Discharge: Monitor water as it is discharging to ensure it does not cause erosion or flooding.
- Protect Local Waterways: If a pool or spa has been acid washed, the water can't be discharged off the owner's property. Water from back flushing pool filters should only be discharged to the sanitary sewer (down a sink or toilet) or on-site septic tank system where it will be treated prior to entering local waters.

WATER/SEWER

I&I - WHAT IS IT? HOW DOES IT AFFECT YOU?

What is 1&1? Inflow and infiltration (1&1) is water, that doesn't need to be treated, entering into our sanitary sewer collection system. This is typically though leaking sewer laterals/mains or an illegal connection from stormwater to sanitary sewer.

Why is it bad? For many different reasons, but the most important being the cost. Greater amounts of wastewater sent to the wastewater treatment plant can result in higher rates for all users. Clean water can also overwhelm the bugs and other bacteria that break down the solids at a treatment plant and make them less effective.


