It's that time of year again when the temperatures warm, the snow melts, and people begin to get outside and become more active. Just as the farmers have begun their preparations for the upcoming growing season, so too has the Village begun preparations for the upcoming "construction" season.

This year Greenville residents will see numerous road projects around the community. School Rd. from STH 76 to Julius Dr. will undergo reconstruction to repair the failing pavement. Everglade Rd. from STH 76 to Greenwood Rd. will be pulverized and paved with a new asphalt surface. Both these projects will affect local traffic, so please make accommodations to use alternative routes once construction begins.

The other major road project that will affect residents is the Hwy 15 bypass project. This is a Wisconsin Department of Transportation project that has been in the works for many years. Construction on the Hortonville portion of the bypass has already begun. Construction on the Greenville portion of the bypass, starting at Lily of the Valley Dr., will begin in late March or early April 2022. Please plan your commute accordingly once this project begins.

Greetings to spring in Greenville!

When I was first campaigning for a position on Town Board, I learned and had reinforced a great many things as I marched door-to-door meeting with you the constituents of our community. Person after person spoke of their desires for Greenville and ideals for our community. Keep a rural feel by having open spaces such as parks as well as managed residential development. You also told me about your desires for delivering quality services (roadways, parks, law enforcement, fire protection, emergency response, etc.), but asked these be done conservatively as you appreciated the low taxes. Without a doubt, these ideals still hold true today.

Also during my initial campaign, I sought advisement from several previous and current locally elected officials as well as attended as many board meetings as time allowed. I often recall a conversation with one person in particular. He encouraged me to run because he knew a change was needed but warned me of the many challenges our community then faced. We talked about the booming years of residential development in the 2000's and the lack of foresight regarding the long-term maintenance costs of the infrastructure being put in place (roadways and water & sewer service). Not to mention the lasting hardships this residential growth would put on our schools and other obligatory services of our community. He advised me to be a force behind much needed change in how we operated as an organization.

These challenges and necessary decisions are what our elected officials and Village Staff face on a daily basis, most of which are too big to be answered in a single day. They take much discussion, consideration, and foresight of which are accomplished through long-term planning and decisions made at meetings open to the public. Too often I read or hear about property taxes are more than high enough to pay for the village services. Reality is the property taxes collected barely make ends meet and barely cover the daily operating costs. Operating costs to run the village have gone up just like costs for you have gone up for groceries, gas, and other essentials. Daily operating costs include administrative service, plowing snow, park maintenance, equipment maintenance, wages & salaries and much more. We took time in 2021 to determine the services deemed as essential by the citizens of Greenville. Changes were made with the elimination of a few undesirable services, but for those that remained it needed to be determined how they should be paid for. Expenses benefiting the greater community will be paid with property tax dollars. Examples include road maintenance, law enforcement, fire protection, emergency response personnel, and other statutorily required services. However, services benefiting individuals or a select group of the community would be charged an appropriate fee. A great example of a service benefiting a select group would be water and sewer. Municipal water and sewer are only available in a portion of our community and therefore is billed separately from property taxes. Examples of services benefiting an individual include fees for a building permit. A new or renovated building benefits the property owner so the fees should be charged to them alone and not the greater community. Prudently the building permit fee is used to offset costs for state required building inspections making this a self-sufficient village service. Another example of a service with individual benefits would be the installment of a fee for brush pickup. This service was used by less than 200 residents which is fewer than 4% of Greenville residential homes in 2021. Why raise taxes for all properties simply to provide a service only a select few in the community utilize?

[DID YOU KNOW ONLY APPROXIMATELY 15% OF YOUR PROPERTY TAXES ACTUALLY GO TO THE VILLAGE? THE OTHER 85% GOES TO THE OTHER THREE TAXING ENTITIES. SO IF YOUR PROPERTY TAX BILL IS \$4000 ONLY \$600 GOES TO THE VILLAGE.]

Many of our communities' challenges remain the same from when we were a town in 2015 to now when as we are a young village. None of these actions mentioned previously are a result of incorporating as a village. They are actions of a municipality attempting to be fiscally responsible in all they are doing. In fact, the only true action done through allowances as a village was to increase law enforcement. The state of Wisconsin allows a one-time change to the tax levy for expenses directly related to law enforcement when moving from a town to a village. Even this decision was not taken lightly. In the end the decision to increase the number of contracted officers through the county was a data-driven decision based on trending increases in crime in our community. Sheriff Deputy Brett Stauber highlighted his activities for a recent five day period in Greenville: intercepting a stolen vehicle, making two felony arrests and locating narcotics paraphernalia, disturbance at the airport which took multiple deputies hours to resolve, theft of tools in progress resulting in two felony arrests, vehicle fire on Highway 15, multiple motor vehicle crashes, liquor license violation checks, a lengthy Child Protective Services investigation, issues at a group home facility in the Village, thwarting several catalytic converter thieves, and not to mention general traffic patrol and enforcement.

How do we promote desirable growth to increase the tax base without putting a burden on our roads, schools, or you the taxpayer? How do we pay for the services offered today with a tax levy that barely covers the day-to-day operations of the Village? We must be smart about how we are managing our tax dollars and because of this, some things need to be changed. Come join us at our open meetings and be part of the positive change for Greenville!

***** Due to a change in state law:** Only the person that fills out an absentee ballot may be the one to return it. This means that you may **NOT** personally return anyone else's ballot but your own. If you're not personally returning your ballot, the best way to ensure it is received is to **MAIL** the ballot using the pre-paid postage already on the return envelope in plenty of time to reach us by Election Day.

Tips to Ensure Your Absentee Ballot is Counted

Too many times, even with reminders and sent instructions, residents fail to complete their absentee ballot correctly, causing it to be rejected at the polls. Here's why:

1. Voters and/or Witnesses did not sign the outside envelope.
2. Voters and/or Witnesses did not put their full addresses on the envelope including the city and state. ***Address is still required EVEN IF you both live at the same address.**
3. Voters include more than one ballot in the same envelope.
4. Voters do something other than fill in the circle with a dark colored pencil or pen. Circling the radio button, using checkmarks and using highlighters to mark selections are all examples we've seen in Greenville.

Floodplain Insurance

Greenville is now enrolled in the National Floodplain Insurance Program (NFIP), which means property owners are able to purchase flood insurance through their insurance agencies. 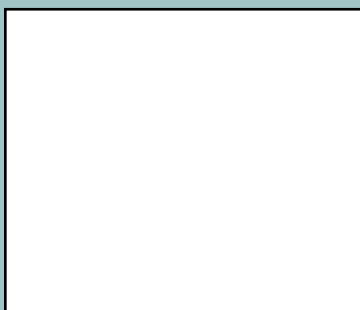

Land Stewardship Committee Works With Village to "Keep the Green in Greenville"

Purchase of Development Rights (PDR) Program

The Land Stewardship Committee (LSC) has been researching the possibility of creating a Purchase of Development Rights (PDR) program that would leverage public dollars to purchase land that would remain in agriculture in perpetuity. This program is a voluntary program where landowners can be compensated for permanently preserving farmland from development through land easements. The Village sponsored and received a 50/50 matching grant from the federal government to help initiate the program. The LSC held a Public Informational Meeting on February 7, 2022, to discuss the benefits of a PDR program. If you missed the meeting, you can view the presentation and learn more about the program on our website at http://cms3.revize.com/revize/greenvillewi/departmentsub_area_plan_project.php.

As part of the matching funds for the grant, the Village Board has directed the LSC to ask the community, through a referendum, if they would support a modest tax increase to support this program. Before a referendum is proposed, the LSC wants to continue to inform the public about the program as well as conduct surveys to understand if a referendum would be supported. Please stay tuned to the website and future correspondence from the Village regarding a survey.

Sub-Area Plans

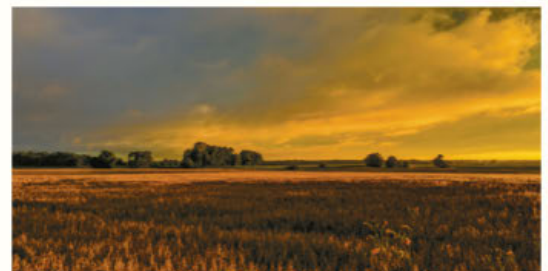
The Village of Greenville has begun the process of developing Sub-Area plans for areas that may develop in the future. The purpose of the Sub-Area planning is to gather community input on how future areas should develop in Greenville. This planning process is consistent with its 2040 Comprehensive Plan and Action Item 4c-2 within Framing Concept 4c: Vibrant Neighborhoods.

The Village held two Public Informational Meetings in February and March to solicit feedback on the Sub-Areas selected. The public were asked to provide comments through a variety of methods including an in-person/virtual meeting, mailed and emailed correspondence as well as an online survey. Data collected will be presented to the Planning Commission and concepts will be developed over the next few months.

Farmland Preservation Tax Credit

In 2020 the Village updated its Zoning Ordinance to create a Farmland Preservation Zoning District. In 2021 the Village rezoned several agricultural parcels that qualified for this zoning designation and the Village's Zoning Ordinance became certified by the Wisconsin Department of Agriculture, Trade and Consumer Protection (DATCP) as a Farmland Preservation Zoning Ordinance.

If you are a farmer or landowner who is engaged in farming and your property is zoned AGD-FP General Agricultural District Farmland Preservation you may be eligible for a tax credit. Public Works Announce Updates & Changes

Yard Waste Site Changes

Due to various accidents and increased congestion at the Yard Waste Site it was determined that the Yard Waste Site would need to be relocated and upgraded. Since 2014, the Village has been working to locate and purchase property for the future Yard Waste Site. In February of 2021, the Village closed on a property 930 feet east of the intersection of Manley Road and School Road. During 2021, the Village designed, permitted, and began to construct the future Yard Waste Site. The address of the new site will be W8031 School Road and is planned to be opened mid-July. Before you are able to use the new site, you will need to obtain a key card/fob to open the gate system. You will be able to purchase the key card/fob beginning in July. The cost of the key card/fob will be \$45; if you have previously purchased a Yard Waste Site sticker for 2022 you will only need to pay \$25. Key card/fob will be renewable from year to year; if you lose your card, you will be charged \$5. The annual renewal fee for the key card/fob is \$40. The details of the operations of the site can be found by scanning the QR code.

Free Tire Drop-Off

Spring Dates:

Wednesday, April 13 – Thursday, April 21, 2022

Fall Dates:

Wednesday, September 14 – Thursday, September 22, 2022

Collection is limited to Greenville Residents only, with a limit of 4 tires per household. Tires will not be accepted at the Yard Waste Site during any other time, however tires can be dropped off at the Outagamie County Landfill for a fee. Tires from businesses are not accepted. Only tires with a rim size of 18" or less will be accepted at no charge. For all tires with a rim size of 19" or larger in size or quantities of over 4, the resident will be charged \$8.00 per tire at the Public Works Office; or \$325.00 per ton if taken directly to the Outagamie County Landfill/Recycling Center (1419 Holland Rd, Appleton).

Brush Pick-Up Changes

The Public Works Department will begin curbside brush pickup on the second Monday of every month, or as weather and operations allow. Effective March 14, 2022 the fee to be added to the brush pick-up list is \$50. In addition to the fees, residents must provide their name, phone number and the address of the pickup location. Residents requesting pickup must stop at the Municipal Service Complex no later than 12:00pm on the Friday prior to pickup to be placed on that month's brush pick up list. Brush will NOT be picked up at any address that has not paid to be added to the list. Overage fees will be applied to any stop requiring more than 20 minutes of chipping.

Street Tree Planting and Pruning

Subdivisions with curb and gutter, and lots with lawns already installed, will start to see shade trees being planted in the spring. Property owners that are scheduled for planting will receive a letter and care instructions prior to planting. Proper care in the first few years after planting is very important for the establishment and health of the trees.

Village staff and ISA Certified Arborists from Selner Tree and Shrub Care LLC will be performing tree pruning services on Village street trees during the coming months. The purpose of the pruning that is performed depends on the size, age and species of the trees. We maintain an inventory of all public trees. Young, developing trees are pruned on a three year cycle while we aim to prune the older, more mature trees on a six year cycle. PLASTIC BAGS

YUCK

TANKS

Tanks & compressed gas cylinders can contain small amounts of fuel and can ignite if damaged. Search "propane tank" in our Waste Wizard to find proper drop-off locations.

Greenville Utilities: Keeping it Clean!

Hydrant Flushing

Greenville Utility will be flushing and exercising hydrants beginning in May. This process typically takes approximately two months.

The Public Service Commission and Wisconsin DNR requires the Utility to flush the water distribution system, including the fire hydrants. Flushing hydrants is essential to keep your water safe and maintaining the distribution system. This also helps to ensure that hydrants are in good working order for the Fire Department's use.

During this process, you might notice that your water appears cloudy and rusty. This is normal and you can still drink the water. If you run the cold water tap that is located closest to your water meter, this will help to clear the water up. If you have questions, you can contact the Public Works Office at (920)757-7276.

Cross Connection Inspection Program

The purpose of the Village of Greenville's Cross Connection Control Program, as defined in the local Ordinance §340-26, is to help eliminate possible contamination of the public water distribution and sewage collection systems. As part of this program, an inspection of your facility's internal water system is to be completed. Inspectors will be reviewing your water system for connections that could possibly contaminate the public water distribution and water collection system. The Cross Connection Control Program is a DNR mandated program that requires the Village of Greenville to inspect a percentage of Village homes each year. This year's inspections will also include an exchange of the home water meter.

Tips on How to Improve Water Quality

Household Hazardous Waste: Cleaning out the garage and keeping our waters clean

We all have the opportunity - and the responsibility - to dispose of waste materials properly. The rule of thumb is: If you wouldn't dump it in the river, don't let it touch parking lots, soil, or any other place where it can be washed into a stream or storm drain. Post this sheet in your garage storage area as a reminder. This will help us change one habit at a time, so we have good fishing, swimming, paddling and waterskiing when the work is done.

HARMFUL SUBSTANCES: Certain household chemicals, when not used up properly, become household hazardous waste. These products can contain the same chemicals as strictly regulated industrial wastes. These products include: cleaning products and wash water, food oils and grease, automotive oil, grease and waste fluids, paint, petroleum-based solvents, rodent baits, batteries, herbicides, pesticides, concrete wash water and sidewalk salt.

HANDLE WITH CARE: To avoid the potential risks associated with household wastes, always monitor the use, storage and disposal of products with potentially hazardous substances.

PROPER DISPOSAL: All of the counties in Northeast Wisconsin have Household Hazardous Waste drop off programs or collection days. Contact your local environmental, health or solid waste agency for instructions on proper use and disposal.

USING LESS: The quantity of waste from a single household may be small, but that quantity adds up fast considering the number of households in Northeast Wisconsin. Consider reducing your purchase of products that contain hazardous ingredients.

Prevent bacteria in our streams by carrying small plastic bags when walking your dog. Collect droppings, tie a knot in the bag, and dispose of it properly. Do not throw pet waste down the sewer. At home, pick up pet waste often. Even waste in your backyard can pollute local waterways. You can flush the waste down the toilet, put it in your trash can (be sure to check your local ordinances first!) or bury it in your yard.

More to Waste Than Meets The Eye

Your dog brings a lot of joy to your life. Enjoying your four legged friend doesn't need to come at the price of clean water. We can have both. But to make it happen, we all need to think a little differently.

Pet waste is not only an unpleasant find on a yard or sidewalk, it carries bacteria that causes beach closings in the summer. Campylobacteriosis and salmonellosis are often the cause of the "24-hour bug". They're transferred through fecal material from an infected person or animal. Toxoplasmosis is carried by a single-cell parasite that lives in infected animal feces (typically cats). In pregnant women, it can pass through the umbilical cord to the unborn fetus, causing serious abnormalities.
