# TOWN CHAIRPERSON

## Jack Anderson



Spring is a time of new beginnings. The seeds of today become the flowers, vegetables and fruits of tomorrow. Spring is also the time when our Town Staff, much like you, get to work on the numerous projects that have been accumulating on our lists as we awaited warmer weather. It is the time of year when local civic organizations are busy planning the events of summer. GYS Opening Day is May 2, Lions Catfish Extravaganza is July 10 & 11, and the Greenville Civic Club Summer Send-Off is August 29. But let's not get ahead of ourselves.

What's going on in Greenville in 2020? The Chip Garrow Memorial Trail is being constructed at Jennerjohn Park, committees are working on plans for developing Field of Dreams Park as well as a makeover to Community Park. Final touches are being completed on the interior and exterior of our new fire & safety building. Our Fire & EMS departments, along with Town Staff, will be organizing a date to celebrate the dedication of this amazing new facility to the Town of Greenville. The Public Works team is focusing efforts on the many significant infrastructure projects throughout our Town including new construction, road maintenance, stormwater management ponds, critical sewer facility reconstruction, and utilities relocation for upcoming major roadway projects. Thank you to all our Town Staff for their tireless efforts to make sure our parks, trails and roadways are well maintained and ready for us to use.

Let's talk road maintenance! With so many projects being initiated, planned, and completed in our incredible town it may seem strange to want to focus a portion of this article on our roads, but year-over-year road maintenance is at or near the top of the list of expenses for

Greenville with annual spend ranging from \$1.5 to \$4 million. Annually Town Staff reviews our over 107 miles of local roads totaling over \$100 million in roadway assets to determine priorities for maintenance needs.

To authenticate these priorities Greenville uses the WISLR application and PASER rating system. WISLR is an internet accessible application which helps local governments manage local road data improving decision-making and ensuring our roadways meet state statute requirements. PASER is a rating scale that uses visual inspection to evaluate pavement surface conditions including surface defects, surface deformation, cracks, patches, and potholes. Roadways are ranked on a scale from 1 (failed - total reconstruction required) to 10 (excellent - no maintenance required). PASER ratings can provide a basis for comparing individual roadway segment conditions and translate them to preferred maintenance options. The distressing truth is over 30% of Greenville's roadways are ranked at a level 4 or lower. This means currently over 32 miles of our local roads are in need of major structural work or total reconstruction. Although we would like to get all these roads fixed it simply isn't currently feasible to do all at once. The estimated mean of road reclamation/reconstruction costs \$129.50 per lineal foot. To fix all the PASER rated level 4 or lower local roads would equate to over an estimated \$21 million. How we go about improving overall road conditions in our community remains a priority for Town Staff and the Town Board. For the benefit of all, we continue to strive to do this in the most reasonable

economic means available to us today. Prioritizing road maintenance, utilizing annual budget forecasting and managing new urban development are a few of the methods we are using to manage this expense.

As your Town Chair, I encourage you to foster the sense of community in Greenville. Welcome a new neighbor, join a local civic organization, get out and volunteer. Give back to the community that gives so much to you. To stay up on the happenings within our community, I recommend citizens link to the Town of Greenville Facebook page. Town staff does an amazing job of posting updates on all items of interest around our town, new projects, and important items of significance.

## What is Incorporation?

*Municipal incorporation is the process of creating new villages and cities from town territory. It is regulated under Wisconsin Statutes Chapter 66 General Municipality Law (s. 66.0201).*

The Town of Greenville has resubmitted an Incorporation submittal to the Wisconsin Department of Administration.

This resubmission reflects the comments of the State's prior determination, providing a revised boundary map and petition to support the incorporation of the Village of Greenville. The revised Village of Greenville has been reduced in size in order to meet the requirements of compactness. The proposed village will be 16.89 square miles in area (versus 36 square miles) and a population of 11,827 based on the 2020 DOA estimates. The remnant town will be 19.11 square miles in area and have a remaining population of 2,969 persons.

Resubmitting a new petition would initially create a separate Town and Village of Greenville. However, should the incorporation pass, the remaining Town could be reunited with the newly formed village via an Intergovernmental Cooperation Agreement between the remnant Town and newly formed Village. This act would be similar to the incorporation of the Town of Menasha to the Village of Fox Crossing. This process does add some complexity and can be confusing to many. Because of this complexity, we attempted to incorporate the entire Town at once.

# PUBLIC WORKS

## Yard Waste Site

The Yard Waste Site is open to all Greenville residents who have purchased a permit to use the site. Yard Waste Site Permits can be purchased at the Public Works Office. Due to the increased operation costs the new charge for the 2020 Yard Waste Site Permit will be \$20. Additional stickers within the same household are sold at a discounted price of \$10 per sticker. Permits are good for one calendar year. The Yard Waste Site Policy, along with accepted material, can be found on the Yard Waste and Brush Pick-Up page of our website. Extended hours of operation at the Yard Waste Site will begin April 1 and are as follows:

**Monday - Thursday 7:00am - 7:00pm**

**Friday 8:00am - 12:00pm**

**Saturday 9:00am - 3:00pm**

**(With the exception of Holidays)**

## Free Tire Drop-Off

- Wednesday, April 15 - Thursday, April 23, 2020
- Wednesday, Sept. 9 - Thursday, September 17, 2020

Collection is limited to Town of Greenville Residents only, with a limit of 4 tires per household. Tires will not be accepted at the Town during any other time however, tires can be dropped off at the Outagamie County Landfill for a fee. Tires from businesses are not accepted. Only tires with a rim size of 18" or less will be accepted at no charge. For all tires with a rim size of 19" or larger in size or quantities of over 4, the resident will be charged \$5.00 per tire at the Public Works Office; or \$175.00 per ton if taken directly to the Outagamie County Landfill/Recycling Center (1419 Holland Rd., Appleton).



## Brush Pick-Up

Brush pickup begins the second Monday of every month, year round. Collection can take up to a week to complete. Residents who would like to participate in brush pickup should call: (920) 757-7276 or email [public-works@townofgreenville.com](mailto:public-works@townofgreenville.com) to be added to the collection list no later than 12pm the Friday before. ## Dumping Ordinance

*The Town of Greenville's Solid Waste Ordinance, §247-9 Prohibited Conduct, states: "No person, Firm or Corporation shall dispose of, dump or bury garbage, yard waste, or refuse, upon any road right-of-way or upon any public or private lands in the Town of Greenville other than upon those premises duly designated and licensed as sites for disposing, dumping, or burying of garbage, yard waste or refuse." If you are found to be violating this regulation and dumping in the Town of Greenville, you may be fined \$50 to \$1,000.*



# “Neighbors Helping Neighbors”

## GREENVILLE FIRST RESPONDERS

**The Greenville First Responders have been busier this year than at this time last year. We ended up with 413 calls at the end of 2019 compared to 346 in 2018 and since the beginning of 2020 to the end of February, we have responded to 73 calls. Last year at this same time period we responded to 63, but there has been very few weather related calls.**

### Safety Equipment Update

Our fundraising drive was a big success; we reached our goal and have purchased the ballistic vests we were proposing to buy. Now each First Responder has a vest and they will be used for what they are meant for. Many thanks to all the residents, groups and businesses that donated, this helps us to do our jobs safer and gives our families some piece of mind. Several years ago, using generous donations, we were also able to buy ballistic vests and helmets designed for active shooter type situations. We have dedicated time to do extra training for this type of scenario.

A group called the Rescue Task Force in Outagamie County includes Appleton, Grand Chute, Kaukauna and Greenville. We are a big part of the group and in case of an active shooter we could get called in to assist.

### Interesting Information on ‘Dry Drowning’

You pay close attention to your kids when they’re swimming or playing in the pool. You make sure a lifeguard is on hand and you never leave your little ones alone near any water -- even the tub. That’s the right thing to do, but there’s still more that you can do to keep them safe: learn the signs of danger after they’re out of the water and what to do.

Health experts define drowning as trouble breathing after you get water into your airways. Sometimes that happens while swimming or bathing. But it can come from something as simple as getting water in your mouth or getting dunked. Although it can be fatal, it isn’t always. You can survive drowning if you get help right away.

You may have heard of the terms “dry drowning” and “secondary drowning.” Those aren’t actually medical terms. But they do point to rare complications that you should know about and that are most common in children.

With dry drowning, water never reaches the lungs. Instead, breathing in water causes your child's vocal cords to spasm and close up. That shuts off their airways, making it hard to breathe. You would start to notice those signs right away -- it wouldn't happen out of the blue days later.

“Secondary drowning” is another term people use to describe another drowning complication. It happens if water gets into the lungs. There, it can irritate the lungs’ lining and fluid can build up, causing a condition called pulmonary edema. You’d likely notice your child having trouble breathing right away, and it might get worse over the next 24 hours.



**According to experts, both drowning events are very rare making up only 1%-2% of all drownings.**

#### Symptoms Can Include:

Coughing, chest pain, trouble breathing and feeling extremely tired. Your child may also have changes in behavior such as irritability or a drop in energy levels, which could mean the brain isn’t getting enough oxygen.

#### What To Do:

If your child has any breathing problems after getting out of the water, get medical help. Although in most cases the symptoms will go away on their own, it’s important to get your child checked out. Any problems that do develop are usually treatable if you get medical care right away. Your job is to keep a close eye on your child for the 24 hours after he has had any problems in the water. If the symptoms don’t go away, or if they get worse, take your child to the emergency room, not your pediatrician’s office.


## Sub-Area Planning & Zoning Ordinance

In the last newsletter edition we shared with you the Town is in the process of updating its Zoning Ordinance and encouraged you to become involved. Since then the Town has contracted with Hoisington Kogler Group Inc. to assist with this update as well as developing Sub-Area Plans for specific corridors in the community based on recommendations in the 2040 Comprehensive Plan.

These locations include the Urban Core (STH 15, portions of STH 76 & 96 and CTH CA, CB & GV) Heritage District (Neighborhoods around STH 15 & 76) and Gateway areas (Major entrances to Greenville) as identified in the Town’s 2040 Comprehensive Plan. This planning process will allow the Town to be prepared for development/redevelopment opportunities in these areas and provide decision makers with the necessary tools to see these areas develop as desired. The planning process will be visionary but grounded in market data analysis and will include the following:

- A Market Study that looks at both residential and commercial/ industrial development that is based on market demand to support future development.
- Architectural design guidelines specific to these corridors and areas in order to be implemented with the Zoning Ordinance rewrite.
- A robust public engagement process allowing the public various opportunities and methods to participate in and contribute its ideas.
- Land use and Multi-modal Transportation.

The public engagement process will utilize online mapping/ survey platforms, stakeholder interviews, public charrettes, public workshops, pop-up events, and public meetings. The public engagement process will start with an online mapping/ survey platform in April and followed up with the public charrettes and meetings starting in May and running throughout the summer. The planning process is anticipated to wrap up in the fall with adoption of the plans and updated ordinance shortly thereafter.



# GREENVILLE SANITARY

## Hydrant Flushing

The Greenville Sanitary District will be flushing and exercising hydrants beginning in May. This process typically takes approximately two weeks.

The Public Service Commission and Wisconsin DNR require the Town to flush the water distribution system, including the fire hydrants. Flushing hydrants is essential to keeping your water safe and maintaining the distribution system. This also helps to ensure that hydrants are in good working order for the Fire Department’s use.

During this process, your water may appear cloudy. This is normal and you can still drink the water. Running the cold water tap that is located closest to your water meter, will help to clear it up. If you have questions, you can contact the Public Works Office at (920) 757-7276.


