



In 2021, we continued efforts to prevent the spread of COVID-19, the City of Harlingen partnered with Valley Baptist Harlingen, Harlingen Consolidated Independent School District, South Texas Emergency Care Foundation, and community volunteers to provide vaccines and boosters at the Harlingen Convention Center.



Dear fellow residents of Harlingen,

We are excited to present this year's annual report to the citizens of Harlingen! So many great things continue to happen in our City even as we recover from what we hope is the worst of the COVID-19 Pandemic.

We're so proud to report that the U.S. Census measured that the City of Harlingen grew by 10.76% compared to Brownsville's 6.69% and Cameron County's 3.36%. Those numbers reflect Harlingen's strong growth pattern over the last 10 years. Our retail sales tax revenues have also more than doubled over the last 10 years from \$14 million to \$29 million, another solid indicator of our growth.



We continued our priority commitment to improving our drainage infrastructure by completing another Master Drainage plan project– the \$2.4 million 9th & 13th Street Drainage Improvements. This is the 27th project completed from our Master Drainage Plan. And the City Commission allocated another \$6 million of CARES ACT funds this past year for additional projects we hope to complete this year.


Our partnership with UT-RGV continues to flourish as we cut the ribbon on the Institute of Neurosciences which houses both research and clinical services for brain health treatment unique to the entire State of Texas.

And our partnership with HCISD and UT-RGV also saw the opening of Collegiate High, the early college campus, which will not only allow our students to complete 2 years of college in High School but to complete 4-year University degrees right here in the City.

We thank the Harlingen Police Department for moving our crime rate lower by 6%. And we are also very proud of what we have been able to do with our COVID Vaccine Clinics, food distributions, and our Financial Hardship Assistance Programs all necessitated by the pandemic.

There are many more accomplishments and milestones for you to read about in this report. I want to personally thank each one of the City of Harlingen employees for a job well-done in 2021.


Finance

The City of Harlingen remains financially sound and anticipates finishing FY 2021-2022 with an estimated fund balance of \$24,109,536. The city's largest revenue source continues to be sales and property taxes respectively. Franchise fees and other taxes come in third.


Harlingen's credit rating is an "AA+" which means credit rating companies see the City as having a very strong capability to meet financial commitments. This has been reaffirmed by Fitch Ratings Inc. which reports that Harlingen has solid revenue growth prospect, superior financial resilience, exceptionally strong gap-closing capacity, and moderate fixed costs. Fitch predicts Harlingen will continue to have strong reserve levels with a strong operating performance. Standard & Poor's Rating Services also reports that Harlingen's economy is stable predicting the fund balance will again remain above 30% of expenditures for the current and next fiscal years.

FY 2021-2022 Budget Highlights include \$2.5 million for street maintenance and overlay projects, \$500,000 for road maintenance including the purchase of a street sweeper, \$220,000 for public safety equipment, and \$578,000 in park improvements including restroom facilities in the downtown area and the reopening of the executive nine at the Tony Butler Golf Course.

As COVID-19 continued to strengthen it's hold on the nation and the demand for vaccines grew, the City dedicated more than 100 employees to conduct vaccine clinics in Harlingen.

Working with nurses and staff from Valley Baptist Hospital Harlingen, Harlingen Consolidated Independent School District, South Texas Emergency Care Foundation (STEC), and community volunteers, the clinics were held bi-monthly at the Harlingen Convention Center as the region worked tirelessly to slow the spread of the infectious disease.



Concurrently, the Federal Drug Administration and The Centers for Disease Control cleared the way for more age groups to get the vaccines and then boosters, so to keep up with the demand, the Harlingen Health Department hired two full time nurses and eight additional healthcare personnel to administer vaccines weekly at the Lon C. Hill Building.

To help our homebound population and lend a helping hand at the City Vaccine Clinics, 15 Harlingen Fire Fighters underwent specialized training preparing them to administer COVID-19 Vaccines to Harlingen residents. Together with STEC Emergency Medical Technicians (EMTs) they've administered hundreds of shots throughout the City helping people with minimal mobility or a form of disability that prohibits them from leaving their homes. Harlingen was the first City in the Rio Grande Valley to implement a homebound vaccination program.



Fifteen Harlingen Fire Fighters volunteered to get specialized training to help administer vaccines to the thousands of people waiting for their turn to get vaccinated.

In an effort to get more people vaccinated sooner rather than later, the Harlingen City Commission approved an incentive program in September for first time COVID-19 Vaccines. The City dedicated \$100,000 of the American Rescue Plan Act Funds for this program. For three months, Cameron County residents were eligible for a \$50 gift card after getting their first vaccine. When the program closed on Nov 30, 1,119 incentive cards had been issued.

In 2021, the City held 74 clinics and administered 28,509 vaccines.

Weekly vaccine clinics continue at the Health Department and a monthly clinic at the Convention Center.













In 2021, Harlingen area adults, teens, and children as young as five years old, rolled up their sleeves to get their vaccines and boosters.

Food Distributions– For almost two years, the City of Harlingen and the Food Bank RGV held monthly distributions at the Harlingen Soccer Complex. Thousands of families in Cameron County have been helped. The food was provided by the Food Bank and distributed once per month by City employees. The effort began in April 2020 when COVID-19 was at its highest levels and many people were out of a job. That year, the City and Food Bank distributed 501,282 pounds of food benefiting 40,115 people. In 2021, 1,117,628 pounds of food was distributed to 88,196 people.



Permits & Development

- Increase in Building Permits by 55.28% with a construction value of \$109,857,469.53 up from \$70,745,821.00 in 2020.
- Increase in new home Permits by 12.3%. We issued 256 permits in 2021 compared to 228 in 2020.
- Increase in permits for Duplex/Apartments by 530% with a construction value of \$34,586,899 in 2021 compared to \$5,487,000 in 2020.

Sam's Club invested \$1 million to renovate the store's interior giving it a brand new look. Harlingen's first Food Park is set to open in March 2022 on Jefferson. This \$500,000 investment includes a stage, dog park, volleyball and basketball courts. Additionally, Gillman is investing \$8 million to build a Honda Dealership on the expressway next to Gillman Chevrolet.





A private investment of \$30 million is bringing close to 100 new apartments to the corner of Ed Carey & Lamb. They are set to open mid-summer. dd's Discounts invested \$900,000 to remodel the old Bed Bath & Beyond and is set to open in October 2022.







Aguilar's Meat Market is joining the Harlingen community in Nov 2022. The family owned business invested \$750,000 to build the store off the Expressway next to Kubota. Party City is planning to build a \$1.2 million store next to the new TJ Maxx on Dixieland Drive. In the same shopping plaza, Spec's Liquor spent \$500,000 to renovate the old Luby's with a planned opening of March

Improvement Projects

Construction continues throughout the City focused on improving drainage and roadways. In 2021, Harlingen dedicated millions of dollars and obtained millions more in grants to fund current and future projects.





The 9th & 13th Drainage Improvement Project was one of the City's largest in 2021. The goal was to increase capacity and mitigate flooding. The \$2.8 million project is now complete. The cost was shared between the City, Texas Water Development Board, and FEMA. It involved replacing the entire storm sewer system, 14 manholes, and 52 inlets.








In 2021, the City of Harlingen also removed the existing line at the retention pond in the South Christian Circle Subdivision and created more flow and capacity; graded 17,900 linear feet of roadside ditches; and cleaned and cleared 60,683 linear feet of drain ditch slopes throughout the City.

Improvement Projects







In 2021, City crews poured 6,360 linear feet of sidewalk throughout the City. Meantime, the \$3.9 million TxDOT sidewalk project also continued in Harlingen. This grant is adding 13.2 miles of sidewalk to several areas of the City including Business 77, I69E, and Harrison and Tyler – both from Dixieland to F Street.





In 2021, the City of Harlingen collected and transported 62,477 tons of solid waste to the Edinburg Landfill and collected 206 tons of recyclable materials at the Self-Drop-Off center on Commerce. The recyclable materials were transported to the McAllen Recycling Center.

Park Improvements



March 2021-Ribbon cutting ceremony for the all new Lon C. Hill Destination Park on Fair Park Boulevard. Phase 2 is already in the design process and it includes building a special needs ball field and extending the walking trail north across the street to run behind Casa de Amistad.



December 2021-Ribbon cutting ceremony for the new HEB Tennis Center. Located at Pendleton Park, this center now includes a pro-shop, air-conditioned space, and a covered patio. The pro-shop includes an office, training room, restrooms, a spectator viewing area, and a lobby. The cost was \$712,000 with the majority coming from a 2001 Certificate of Obligation Bond and \$115,000 from HEB to resurface all 14 courts.

Park Improvements







July 2021-Commenced new B-Cycle Bikeshare Program with new bike rent stations at Destination Park, McKelvey Park, Museum, and Hugh Ramsey Park. In November, the Library opened the state's first automated 24-hour library by Envisionware at Destination Park. Additionally, this park now has free Wi-Fi. Also in Nov, the City hired a contractor to revamp the bridge on the Executive 9 at the Tony Butler Golf Course.



A Kayak Launching Facility is under design thanks to a grant from the Texas Parks & Wildlife. The facility will be at McCullough Park and allow residents and visitors to kayak up and down the Arroyo Colorado.


