Supervisors of the Checklist  
Tuesday, October 11, 2022, 3:00 PM EST

The Hooksett Supervisors of the Checklist were in session at Town Council Chambers, Hooksett Municipal Building, 35 Main St, Hooksett, NH per RSAs 654: 26, 27, and 28. The meeting was held to approve the changes of voter registrations since the September 13, 2022 State Primary.

**CALL TO ORDER:**

SOC Brennan called the meeting at 3:00 PM.

**PROOF OF POSTING:**

The meeting was posted as required.

**ROLL CALL – ATTENDANCE:**

In Attendance: Barb Brennan and Mike Horne. Kim Daggett was excused.

**MINUTES REVIEW:**

Minutes from September 13, 2022 were reviewed. Barb Brennan motioned, seconded by Mike Horne to approve as written. Approved 2-0.

**OLD BUSINESS:**

- Data entry for the September 13, 2022 State Primary has been completed except for items under New Business. The Checklist and CVAs will be turned over to the Town Clerk.

**NEW BUSINESS:**

- Voter Registration Forms received by the new Town Clerk and New Deputy Town Clerk are still missing required information (what documents proved citizenship, signed/dated "Received by", etc.). Letters will be sent to four voters, asking for needed information.
- The ballots of two voters (300552079, 300552078) on the Sep 13<sup>th</sup> State Primary Checklist were cast UNK. Both had completed Party Change Voter Registration Forms when they received ballots from the Town Clerk which could not be acted on. Based on these forms, a decision was made to correct their ballot choice to REP and votes corrected. (Corrections were made after the updated alpha checklist dated 10-11-2022 to be posted was run).
- A request to attend a voter registration at Pinkerton Academy on October 25, 10:45-12:30pm was discussed and Mike will contact the POC to confirm. Students will need to provide required documentation (ID, age, domicile, citizenship) vs. accepting lists provided by the school.
- Mike will reach out to SNHU to find out if they are having any voter registration events. He will also ask for a list of current student domiciles located in Hooksett.
- Efforts to find volunteers to assist the SoC at the November 8<sup>th</sup> General Election will continue.
- Mike ran the updated alpha checklist report and will get it printed and posted by the end of the day.

**VOTER REGISTRATIONS AND CHANGES TO THE CHECKLIST:**

- 64 voters were removed due to registering in other NH cities/towns.
- 64 voters were approved to be added or have status (name, address, party) changed.
- 1 voter was removed due to registering in another state
